


Minutes of Compton Bishop Parish Council Meeting 6 April 1994

Mendip Society and Mendip Newsletter There was nothing of specific interest to the Parish, leaflets were distributed.




In response to an enquiry to SCC Environment Dept by Cllr Clarke regarding the junction of Cross Lane & the A38 a letter states that the possibility of another speed camera site is being investigated and the feasibility of traffic lights at this site is also under consideration.

Noticeboards Having received a quotation for a noticeboard, the Chairman enquired about the cost of a carved header for same. As this quote was considered excessive alternatives will be sought.

Disabled Ramp - Memorial Hall It was agreed that a permanent ramp might prove a greater danger to safety due to the slight incline - Chairman will consider the design of a temporary removable ramp.

Fans - Roof Space - Memorial Hall As an energy saving exercise the Chairman had costed fans to provide a down-draught and to circulate the warm air which rises into the roof space. Chairman will progress.

Footpath Survey Cllr Clarke considered the maps on file to be inadequate for the needs of the survey, the Clerk will arrange for a larger scale map to be made available for this purpose.







9/94/02 Traffic Speed, Old Coach Road The results of the recent survey have now been received. They found that there were an average of 1600 traffic movements daily of which two-thirds travelled at speeds up to 35 mph and one-third travelled at speeds between 36 and 50 mph, there were of course those who recklessly travelled at higher speeds. The results were similar to those where a 30 mph speed limit is in operation and it is therefore felt that a speed limit would not change anything. The Chairman has acknowledged the report and has asked for guidance regarding the SCC policy regarding traffic calming measures.
