MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 19 JUNE 2006 AT DEVAUDEN VILLAGE HALL

1) OPEN SESSION

Mr and Mrs Clelland stated that they were here to discuss plan DC/2006/00144 Change of use at The Dorlands Kilgwrrwg from residential to care home for adults with learning difficulties. They stated that they were concerned about the many inaccuracies in the agent's letter accompanying the planning application. The plan claims that it is only 2 properties affected but is actually more. It is not clear what degree of disability the residents will have and the land is not protected by a fence and it is steep. There is a concern that residents may wander from the property and some will have challenging behaviour. It is on a single track road which will mean an increase in traffic on a road that is already inadequate. Cllr Cooke stated that in principle she had no objections to such homes but there were many inaccuracies in the submission. The staff resident ratio is not clear.

Cllr Williams proposed that this plan is deferred until next meeting on 31 July at Itton. CM to contact planning department to defer decision. JW to organise site meeting for 7.30pm on 22 June. Members of the public left the meeting.
