# MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 21 AUGUST 2006 AT ITTON VILLAGE HALL

#### 1) OPEN SESSION

David Lucas stated that he wanted to discuss the mobile home and paddock at Devauden Court (refs DC2006/00576 and DC2006/00299). He stated that he wanted to raise the point that the mobile home and hard standing were put in place before the planning consents. He said he believed that the applicant would just carry on riding roughshod over the planning regulations. Jane Lucas said that these 2 retrospective applications were suggesting that the stud farm already exists. Cllr Williams stated that DCC had no problem in principle with the stud farm so approving applications for the mobile home and paddock was not contrary to the original decision on the stud farm. Cllr Knight said that there were already about 30 horses being kept at the site and one was lost last year so that they installed the mobile home to have someone on site. Jane Lucas said that these two applications were only posted very close to the mobile home so it was not obvious that plans had been submitted. In light of this Mrs Lucas requested that DCC look at the plans again to make further comment. County Cllr Greenland said he had the commitment of the planning committee to look at all applications from this applicant at this location to be considered as a whole. All these applications will be looked at together. He also said that under planning law the notice has to be either posted by the location or the closest residents have to be informed. MCC try to do both as far as is possible. Cllr Greenland also stated that it is planning law that retrospective applications have to be looked at as if they were ordinary applications. The Cllrs agreed that it would be possible to write to MCC expressing that a large number of residents have on 3 occasions voiced their strong objections to the stud farm development including the siting of a caravan and creation of a paddock. They have also expressed their concerns regarding the procedures adopted by MCC especially the lack of prior notification in the area. We trust that you will take this into account when making your decision.

Ms J Howell asked what would happen after the 3 years that the caravan had been approved for in DCC's recommendation. Cllr Williams stated that future applications would be looked at the time but having approved a caravan did not automatically mean that a further development would be approved.

The members of the public left the meeting.
