# MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 24 SEPTEMBER 2007 AT DEVAUDEN VILLAGE HALL

# 1) OPEN SESSION

Mr Moore expressed that he was there to discuss the Deer Larder at Itton, planning application DC/2007/00902. Cllr Williams consulted the other councillors and it was agreed to discuss this plan out of order for the benefit of the public. Cllr Williams summarised the points that were made in the correspondence received by DCC and sent to MCC. She then stated that she visited the site yesterday and showed a series of photographs that she had taken. Mr Moore commented that the additional concrete area was not mentioned on the original plan and it is not clear what it is there for. He also commented that the Deer Larder is close to houses and you really need to visit the site to see how close it is as it is closer than the plans suggest. As a result of this there does not appear to be any opportunity for landscaping/screening as it is only about 12 feet from the lane. Cllr Powell reported that he had not found anyone in the community who was in favour of it and in fact most are quite anxious about it. CC Greenland stated that the Forestry Commission was within its rights to make a retrospective application and that MCC would have to treat it as any other application. Cllr Williams reported that at the meeting in June there were 25 people who all objected and had concerns about Health and Safety and pollution. She then stated that all the points made in the letters received were relevant with the exception of comments about this being done without planning permission.

Cllr Powell proposed that Devauden Community Council rejects the application on the basis of the following points and the high level of objections locally;

- The project was launched without prior consultation although there has been consultation with local residents and the Community council since.
- Lack of portability although it is described as portable the concrete base and other concrete structures are not portable.
- o Inaccuracies in the site plan distance from the unit and houses and roadway. Also additional concrete has been laid which is not on the plan.
- o Pollution concerns about the wash down slab, soak away and water supply, reflux valves and drainage.
- Electricity supply
- Itton earth fault
- o Butchering on site
- The felling of trees limitations on the amount of screening that can be achieved.
- Access via School Lane increase in traffic.

Seconded by Cllr Williams. 5 voted in favour and 1 abstained. Recommend refusal. Mr and Mrs Moore left the meeting.

PC Mason delivered the crime report for the period which is attached. He informed the meeting that the next Devauden PACT meeting will be Tuesday 6 November at 7.30pm and posters, notifications will be issued.
