Mr Lucas said he was here to speak about the proposed stud farm at Llanvihangel. He said he and other residents are concerned about the access question which is still unclear. It is still vague about what the associated works are and we feel side lined. Also despite lots of contact and emails with the planning department no further progress seems to be being made. CC Greenland said he had just come from a meeting with the Head of Development Control and can confirm that there has yet to be a response from the applicant regarding the additional detail required by the planning department. At the moment it looks like access will be via Church Lane and Star Pitch. Mr Lucas said that the traffic in this lane has already doubled recently and with the extra 45 vehicle movements planned, it will be just too much. CC Greenland clarified that MCC would not put in a compulsory purchase order to widen the lane for access. Also the highways department are looking at the plans and access issues. CC Greenland said he was satisfied the planning officers had done all they could at this stage. Cllr Knight asked what was happening about the barn being used as stables. CC Greenland confirmed that Enforcement has requested that a retrospective planning application for the change of use must be made. Clerk confirmed that plans had not been received.
