### MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 30 APRIL 2007 AT DEVAUDEN VILLAGE HALL

### 1) OPEN SESSION

Mr C Octon addressed the meeting informing them of the proposed deer larder at Chepstow Park Woods. There has been a concrete plinth built on which will be a chiller unit. Also constructing a washery for vehicles. The deer will be brought from across the Wye Valley. Residents are concerned that planning permission has not been applied for, DCC have not been consulted. Forestry Commission have sent a letter to the residents of school lane but only on the day the concrete was laid. There may be health risks from effluent, insects, noise and traffic. We the residents are asking for DCC and MCC to get more information and then use whatever powers they can to stop the project.

CC Greenland said he has spoken to the Forestry Commission and it seems that they have been culling deer and taking them to a facility near Mitcheldean which is now at capacity. At the end of March they were given some unexpected funding that had to be used by the 'year end', for a new Deer larder. The Forestry Commission went to MCC and claimed crown estates exemption for installing a temporary structure for up to 6 months. So what they have done is legal but will have to put in a proper planning application which will include public consultation. When this is received DCC and residents will be able to put their case. He assured the public that this case would go to the planning committee and would not be dealt with by delegated powers. Cllr Williams asked if anyone had seen the facility at Mitcheldean. One of the residents said he had asked but the Forestry Commission would not tell him where it is. Cllr Williams proposed that DCC clerk writes to the Forestry Manager and copies the planning officers, expressing local concerns made at this meeting. Clerk to email a copy of the letter to Mr P Wallace.

PC Mason presented the crime summary for the month which is attached. He then went onto state that he would organise a PACT meeting at Devauden in the next few weeks and would inform the councillors in due course.
