MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 19 MAY 2008 AT DEVAUDEN VILLAGE HALL

IN ATTENDANCE: C Martin (Clerk) Members of the public (list attached to the file copy minutes)

1) OPEN SESSION

Cllr Williams opened the meeting to ask what the members of the public wanted to discuss. They confirmed they were here to discuss the stud farm Plan DC2006/01437. Cllr Knight explained that the amendment to the plan was a well put together bat survey for which MCC should be commended. In addition there were amendments to the access on the plan although it was not clear what these were from the accompanying plan. Cllr Williams reviewed the MCC documentation and concluded that DCC has to make observations on the amendments. To summarise the situation so far Cllr Williams read from the DCC minutes of 29 October 2007, item 6.6. CC Greenland explained that this is an amended plan received by MCC in April and shows amended access site. Cllr Knight said that it does not address the wider aspects of access on the approach lane and Llansoy Road.

Ms Thomas said she was aware of the applicant's traffic report by Ron Kelly but it does not seem to give a fair view of the traffic issues. There is a blind bend and Church Lane could not cope with the traffic. Those of us objecting are prepared to have our own traffic survey. Cllr Williams asked if the access has been changed. Mr Johnsey said they had used the suggestions of the traffic report to make the access safer. He also said that there has been a further highways report.

Ms Lucas made the point that the land marked as highways on the plans was not as wide as the 4m stated in the traffic report. She also said that the bat report recommends no lighting and there are other environmental issues. Cllr Knowland said that any approval of the plans by MCC would have to therefore include appropriate conditions to ensure that the bat survey requirements are met.

Cllr Williams summarised that there seems to have been some movement forward but we still don't have additional highways report. Mr Johnsey said the site is already a farm so a stud will not increase the traffic.

Cllr Williams confirmed the meeting was prepared to take this plan out of order. All DCC councillors present agreed. Councillors agreed that Clerk should write to MCC with the following observations;

- 1. Despite the amended plan we still do not have clarification on the access issues relating to the access roads, in particular Church Lane and Llansoy Road.
- 2. The Community Council is please to have received the bat survey but would like to see further environmental impact reports to consider other issues.
- 3. We are awaiting further traffic survey information commissioned by local residents.
- 4. The full extent of the development is not clear as there have been several changes and amendments to the plans.
