CC Greenland gave an update on the road works at the Green Devauden - the installed kerbs have been removed to enable additional parking at the hall when functions are taking place.

## 9) WARD REPORTS

**EH** – stated wanted to thank MCC for the new road between Itton and Chepstow. CC Greenland commented that there is a new structure in highways department and the operations section which maintains the roads will be finding and opening up gullies to reduce standing water that is responsible for erosion.

CK – raised the issue of additional help for the churchyard maintenance in the community, especially for Llanvihangel Tor Y Myndd/Wolvesnewton which received no support for green grass cutting as has no open public spaces. CC Greenland said that the community council's contribution to grass cutting would not be collected this year even though we had agreed to pay it. The payments will not start until next year. MP suggested that the donation of £25 per church should be raised to £50 per year. Unanimously agreed to pay £50 per church per annum upon request by individual church council.

JW – reported attendance at '1<sup>st</sup> response' meeting. It is early days but there will be more work to see if it is viable to have a defibrillator and trained volunteers in the community. The health authority would provide half the capital cost and supply all the training, but the community would have to raise about £700.
