MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 28 JANUARY 2008 AT DEVAUDEN VILLAGE HALL

1) OPEN SESSION

Mr Lucas stated that he and the other members of the public were at the meeting to discuss the proposed stud farm at Llanvihangel Court. He made the following points about the planning applications 1) The highways department have reported to the planning department and they appear not to see any problem with the increased traffic although previous reviews by highways seemed to suggest that the increase in traffic would be too much for this narrow lane and access. 2) Planning department is very difficult to get hold of and are not returning calls – they appear to think that there are no issues. 3) There still appears to be a question over the existing buildings and what they will be developed into. Planning consent has been given for a dwelling but this would have to change if they were to be used in some other way related to stud farm.

Cllr Williams stated that at the November meeting DCC wrote to the Head of Planning requesting clarification and further information about the relevant applications. Clerk confirmed that no response had been received to date. CC Greenland said that the planning officer had not yet written up the report on the development as are awaiting a bat report. The report from the highways department requires improvements to the junction and passing places along the lane before the development starts. In this case a condition would be put on the planning permission and if the owners of the land were not prepared for it to be used to improve access then the development could not proceed. CC Greenland confirmed that he will go to the relevant planning committee and will ask that the committee come to view the site to see if it is acceptable for the volume of traffic. Cllr Knight said he would also be going to planning committee when the date was known. CC Greenland suggested that it is now unlikely that DCC would get any further information or feedback from MCC planning.

Mr Bowen asked if highways were happy with the increase of traffic on the Llansoy road let alone Church Lane. In light of the highways department report and apparent acceptance of the applicants report CC Greenland suggested that the residents proceed with their own report as quickly as possible. Cllr Williams said there was little more DCC could do at this stage and would leave the matter to be progressed by CC Greenland at the relevant planning committee. She thanked the members of the public who left the meeting.

PC Cowburn introduced himself and said that he would aim to attend at least half of our meetings as he now had an area that was bigger than PC Mason's area, so had 9 community council meetings per month. He presented the incidents for 23 Dec -23 Jan (attached to file copy). PC Cowburn left the meeting.
