### 1) OPEN SESSION

### 2) CONFIRMATION OF MINUTES

Minutes from meeting of 24 August 2009 were agreed and signed by JW and CM.

## **MATTERS ARISING**

- **3.1** CM has written to the forestry commission about the lane at the side of Devauden Village Hall. A reply has been received to state that they have investigated and rectified the problem. File.
- 3.2 Telephone call from Ms Natasha Shallcroft, describing herself as a friend of the occupant of a property referred to in DCC minutes of 25 June 2007, requesting that the occupant's name be removed from the minutes. CM had already contacted One Voice Wales who advised that in future names should not be put in the minutes if requested. However to remove a name retrospectively from the minutes of June 2007 would require meeting agreement and a minute in the current minutes. It was agreed that CM should contact Ms Shallcroft to request that she ask the occupant to contact the Clerk to discuss how she wants to proceed. CM will also contact MCC for advice.
- 3.3 Notice board for Itton Quotes are being awaited and the councillors approved the purchase of a noticeboard from Greenbarnes if none of the other quotes are suitable. Clerk to place order when quotes are received and confirmation received from JW.
- **3.4** Allotments NK will look into trimming the hedges. JW will also speak to allotment holders and let them know that it will not be possible to erect a shed on the allotments or supply water.
- **3.5** BT offer to sell the red telephone boxes to the community council. Clerk contacted MCC and a letter has now been received from Mark Lloyd to explain that representations have to be made to BT via MCC. CM will confirm that DCC would like to adopt the 3 kiosks in the community.

CM to write a letter to be sent to JW for forwarding to hall committee outlining that the Ferard room is damp and unpleasant; it is often untidy and is not fit for public meetings. Inform them that DCC is temporarily cancelling the meetings until the room has improved.
