## MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 18 MAY 2009 AT ITTON VILLAGE HALL

### 1) OPEN SESSION

Mr Paul Ebrey stated that he had come to talk about his planning application - DC/2009/00419 – Retention of garage building and change of use of land to be part of cottage's cartilage, Dorland Cottage, Devauden. The councillors agreed to discuss the application out of order. Cllr Cooke commented that she had not had any objections from the neighbours about the development. Mr Ebrey explained that this was not retrospective planning in the usual sense as the plans for the garage had been approved under permitted development as instructed by the MCC planning department. In November 2006 a planning enforcement officer had said it was ok to continue building the garage. In February 2009 an enforcement officer called and said the garage was not in the curtilage of Dorlands Cottage. Since then Mr Ebrey said he has had meetings with the planners who advised him to reapply which is what this application is. Cllr Knight proposed no objections; recommend approval seconded, by Cllr Hall. All voted in favour. Meeting agreed to include a statement on the planning reply that this applicant had already been advised in 2006 by MCC planning department that this was acceptable development under permitted rights. Mr Ebrey left the meeting.

CM will write to the allotment holders advising them that the fee will increase to £20 from 1 June 2009 and they will be expected to pay this fee from 1 January 2010. The letter should outline that the increase has been made to cover the costs of administration, maintenance and insurance; also that there will be an annual review going forward. CM also to write to the new allotment holder to inform him of the fee and that he will have to pay half the fee for the remaining 6 months of 2009, i.e. £10 and thereafter the annual fee will be £20 per
