Repair renovate and restore Ty Mawr farm to include roof, installation of wiring, under floor heating, power points, doors, floors and windows and to remove partition wall to create open plan kitchen dining area, Ty Mawr Farm, Llanvihangel tor y Myndd. No objections. Recommend approval.

### 7) COUNTY COUNCILLORS REPORT

CC Greenland informed the meeting that the cabinet has been setting the budget and there will be some challenges over the coming year to keep a cap on the council tax while maintaining essential services. The public finances are under strain and it is expected that capital budgets will be slashed. There has been a review of the senior management structure by the new Chief Executive. There will be subsequent changes which should save between £600,000 and £900,000.

The Stud farm planning application will be going to the planning committee next week. There will be a site visit later this week. The officers' report should be out tomorrow and DCC can expect a copy. DCC can send a representative to the planning committee if available.
