5.2* Response to the Monmouthshire Local Development Plan – Proposed Rural Housing Allocations

Dear Sir

Monmouthshire Local Development Plan (LDP) Preferred Strategy Consultation on Proposed Rural Housing Allocations Please note our comments on the above report:

We query the allocation of 15 houses to Devauden village. How can this figure be justified as no specific housing needs has been carried out in the Devauden Community Council area.

All of the plots identified seem very large for the proposed allocation.

We are concerned that the size of PV04 seems excessive for the 15 houses indicated as required for the area, especially in view of the housing density in other areas of the village.

What restrictions would there be on any future development on any part of a preferred site that was not used for affordable housing?

Site PV04 is less intrusive than CS/0024, CS/0064 and CS/0032 but it is highly visible from Churchfields, Wesley Way, Wesley Gardens.

Site PV04 is clearly visible from Wolvesnewton, Newchurch and Kilgwrrwg.
