Boundary changes will necessitate the redrawing of community council ward boundaries. This will split well established, workable rural communities disenfranchising the current electorate. Little attention appears to have been paid to the rural nature of some communities in the Monmouthshire area. The emphasis appears to be ensuring that there is an equal number of electors to each county councillor irrespective of the differences in the role of a county councillor in a rural area compared with those representing more urban areas.
