## MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 28 SEPTEMBER 2010 AT DEVAUDEN VILLAGE HALL

#### 1) OPEN SESSION

Mr Jones introduced Mr Edmunds who gave a short presentation on the successes of recycling to date and proposals to increase the amount of recycling in Monmouthshire. He explained the likely timescales for the community which will mean fortnightly collections of refuse and weekly collections of recycled material and 'green' waste. It is likely to start in this area in spring 2011 and MCC will happily site advisors in the village to answer residents' queries nearer the time. AW asked when MCC would be able to recycle tetra packs. Mr Edmunds said the council was always trying to improve its recycling and was looking into this. KR stated his concern about the risks of fortnightly collections as animals get into the bags. Cllr Greenland said that the fortnightly collections had increased recycling in the pilot areas where it had been undertaken. Mr Edmunds stated that there had been no complaints about the fortnightly collections in the pilot area. Cllr Hall thanked Mr Edmunds, Jones and colleague. They left the meeting.

PC Cowburn gave his apologies to the meeting via the clerk and sent the incident report which is at the end of the minutes.
