MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 28 JUNE 2011 AT ITTON VILLAGE HALL

COUNCILLORS PRESENT: M Powell, K Reece, N Knowland, A Duffield, A Williams, A Cooke, J Williams (chair) **IN ATTENDANCE:** C Martin (clerk), Mr J Rowlands (public) **APOLOGIES:** PC Cowburn, E Hall, CC Bob Greenland,

1) OPEN SESSION

Mr J Rowlands asked about progress with getting the bell sited in the church. Cllr A Williams presented a quote for £580 from Colin Evans, including a detailed drawing and details of materials. As this is a one off bespoke piece the councillors agreed to accept the quote and have the oak frame made and sited in the church. Mr Rowlands expressed his appreciation. Mr Rowlands asked about some sort of commemoration in the village to John Wesley who first preached in Wales at Devauden. CC Bob Greenland has spoken to Paul Matthews (MCC CEO) about this and other tourist information and Anne Jones at MCC has taken it on as a project. Any installation will require the support of DCC. The councillors agreed in principle but would need to see detailed proposals before giving their backing.

PC Cowburn was not present so the chair read out the incidents listed at the end of the minutes.

2) CONFIRMATION OF MINUTES

Minutes from meeting of 24 May 2011 were agreed and signed by JW and CM.

3) MATTERS ARISING

- 3.2 BT payphone adoption letter from BT but only referred to Devauden box. CM spoke to them on the phone and more information will be forwarded. They are now aware that there is more than one phone box, but no further correspondence has been received.
- 3.3 Highways form reply from 28/5/11. File.
- 3.4 CM reported that Hood Memorial Hall has now agreed to let the mobile One stop shop stop in the village hall awaiting decision on how the staff can get access to toilet facilities. Chair suspended the standing orders so that Mr Rowlands could participate in the discussion. Mr Rowlands suggested DCC purchase a key box but would then be responsible for its use. Clerk raised issues of security and DCC liabilities. It was agreed that Mr Rowlands would find out from the hall insurers what the implications of such a box would be. The councillors agreed that DCC would be happy to pay for any such box. The standing orders were reinstated.

He confirmed that the preferred site for Devauden is Well Lane. He also said that even if it was accepted as part of the LDP it would still have to go through the usual planning process. AW offered to attend the meeting but was not fully conversant with the issues. On hearing that Devauden would probably not be discussed
