# MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 26 JULY 2011 AT ITTON VILLAGE HALL

COUNCILLORS PRESENT: M Powell, K Reece, A Duffield, J Williams (chair), E Hall IN ATTENDANCE: C Martin (clerk), Mr J Rowlands (public), PC L Thorpe, APOLOGIES: N Knowland, A Williams, A Cooke, CC Bob Greenland.

#### 1) OPEN SESSION

Mr J Rowlands asked about how soon the old school bell would in its housing and erected in the church. JW read out Mr Rowland's email thanking DCC for arranging it. It was agreed that AW/clerk would report back at the next meeting. Mr Rowlands also wanted to know how he could get a copy of the standing orders. JW said it would not be possible to let him have the council's copy but asked the clerk to try and download part 2 from the OVW website.

PC Thorpe introduced herself and said she was pleased to be working in this area. She read out the incidents listed at the end of the minutes. For contact PC Thorpe suggested using email and her direct line 01633 642068. MP and EH reported that there had been problems on the Usk to Chepstow road with motorbikes racing. PC Thorpe reported that there is a community group in Shirenewton that is attended by the police that is looking at this. Also there have been some temporary signs erected by MCC.

- 3.1 BT payphone adoption letter from BT but only referred to Devauden box. CM spoke to them on the phone and more information will be forwarded, but it looks like the Itton and Cobblers Plain boxes are not up for adoption. A contract for the Devauden box has been received and will be signed and sent to Kazoo/BT.
- 3.2 Highways form reply from 28/5/11. File.
- 3.3 KR reported that he had not removed all the debris from the verge but was intending to do so.
- JW reported that the Hood Memorial hall meeting had minuted that DCC would hold a key for use by the OSS mobile workers to use the hall facilities. JW noted that this was not actually the case as a DCC meeting had not agreed this however in light of the fact that the hall insurers have said that a key box is not permissible this may be the only thing to do. The councillors agreed that this was the best option and instructed the clerk to find out when the mobile OSS was going to be visiting the village. KR/JW and AD said they would all be happy to act as key keeper on a rota basis to be determined when we know the dates.
