MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 30 AUGUST 2011 AT ITTON VILLAGE HALL

1) OPEN SESSION

Mr Modget said he attended the meeting to have it put on record how much he appreciated some of the things done by DCC. In particular;

- 1. The precept has been maintained for several years at the same level.
- 2. He said he wanted to thank DCC for obtaining the school bell for the community, for paying for and organising for it to be mounted and installed in the church.
- 3. Vigilance in reporting pot holes and highways issues and ensuring repairs are made.
- 4. He said he was dismayed to learn that Devauden almost lost the opportunity to have regular visits by the mobile One Stop Shop as Hood Memorial Hall requested payment for parking in the hall grounds. Due to DCC's efforts and willingness to be key holders it now looks like the village will have this opportunity.

Cllr J Williams thanked Mr Modget for his kind comments and said that the community council very much appreciated his attendance at the meeting. Mrs Modget said she attended to accompany Mr Modget and felt the same way.

Mr Rowlands endorsed what Mr Modget said and asked what the progress regarding the school bell was. Cllr A Williams said he had been away but that he would look into it and feedback to Cllr J Williams, who would contact Mr Rowlands in due course. Mr Rowlands thanked the clerk for getting a copy of the standing orders to him. Chair closed the open session.

2) CONFIRMATION OF MINUTES

Minutes from meeting of 26 July 2011 were agreed and signed by JW and CM.

3) MATTERS ARISING

- 3.1 Cllr J Williams reported that sadly Mrs Anna Gilvear who was a DCC councillor, has died at the age of 62. Cllr Williams will send a card of condolence to her family on behalf of DCC.
- 3.2 BT payphone adoption A contract signed by DCC and BT for the 3 boxes has been received. JW requested that the clerk lets BT know that we want to keep the electricity. Clerk to put all three boxes on the insurance. DCC will discuss how to use the boxes and solicit local opinion.
- 3.3 Highways form reply from 7/7/11. File. The response saying that it is not required regarding the 'unsuitable for large vehicles' sign at the B4293 and 58.7 was not acceptable. Clerk to return the highway form requesting a site visit with AC and NK. File highways form.
- 3.4 Hood Memorial key for use by the OSS mobile workers to use the hall facilities email from OSS staff to say will contact us in September when the trial period is over.
- 3.5 MCC payroll for clerks have been notified by MCC that cost will be £75 per year and they have sent a form to be completed. Agreed that the clerk should respond and be set up on the MCC payroll a soon as possible.
- Standing orders JW said it was a long time since we discussed standing orders. She passed round several copies of the model standing orders. She said we agreed many years ago that meetings should last no more than 2 hours. We have though never designated a period of time that members of the public can speak for. MCC allows 4 minutes. W need to discuss this and what we think is a reasonable amount of time. NK said that he would not like to restrict it as the public should have their say. AW said that we sometimes overrun for reasons not related to the public speaking. MP proposed that the public should not speak for more than 4 minutes subject to the Chair's discretion. Seconded by EH. A counter proposal was put forward by NK; Maintain the current procedure, seconded by AW. Four councillors voted in favour and 4 voted against. The Chair has the deciding vote and voted against so the proposal is not carried. The original proposal went to vote and 5 voted in favour and 3 against so the original proposal was carried.

AC – Ty Bettws Hill the road is still falling away as previously reported. Clerk to put on highways form again.

AD – 18 Churchfields and School house (next to the church)– the hedges are overgrown at both properties and causing a hazard on the footpath, causing people to walk in the road.

NK and **KR** – will organise the clearing of the debris from the verges in Devauden.
