MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 22 NOVEMBER 2011 AT DEVAUDEN VILLAGE HALL

1) OPEN SESSION

PC Thorpe informed the meeting about the incidents which are summarised at the end of the minutes. She also mentioned that there had been some complaints about in considerate parking by the hunt followers. Cllr J Williams raised concern of some residents over the culling in Chepstow Park Woods and whether the police were informed as it would be helpful to know when it was happening. PC Thorpe said she was not sure but would find out. Cllr J Williams thanked her for the report and PC Thorpe left. Mr Phipps said that the Saturday before last two vehicles had parked in his drive on hunt day and when spoken to they were unpleasant to his wife.

Mr Rowlands gave his thanks to the CC and Mr Evans for the superb job that had been done on the school bell. Cllr Williams confirmed that there would be a dedication of the bell at the village carol service in December. Councillors agreed this would be appropriate and JW will communicate with Father Michael.

Mr Rowlands then raised the John Wesley Commemoration on the village green. He asked for a letter from DCC in support. Cllr Cooke commented that DCC cannot give permission for a structure on the green as it would have to go to the Welsh Assembly as it is common land. It was agreed that the Clerk would write a letter in support when the details were forwarded by Mr Rowlands.

Cllr Cooke informed the meeting that Rev Jeremy Winston had passed away the day before.

9) WARD REPORTS

JW – Deer culling in Chepstow Park Woods – JW said would wait until we hear from PC Thorpe, but it may be appropriate to erect a warning sign to alert people to the culling times.

AD – sign post at Cole Lane indicating is a no through road has been hit and has been damaged, at corner of B4293.

AC – R82 – 100 yards west of Kilgwrrwg crossroads is a damaged horse warning sign that is still on the floor and needs repairing.

R82 - $TY\ Bettws\ Hill$ the road is still falling away as previously reported.

MP – Itton Common opposite the telephone box on the corner is being run over by vehicles – can MCC look at it and offer a solution – possibly a higher curb. MCC to contact MP.

EH Lights on the entrance to Foxes Barn Itton are very bright and can be mistaken for headlights from both directions at night. **KR** – Olbury Power Station – Went to a meeting at which the emergency plans were discussed. If there is a very bad incident the 14 km exclusion zone would reach Devauden. Gwent police would be notified by Avon and Somerset police and a disaster plan

for medication is in place.
