MINUTES OF DEVAUDEN COMMUNITY COUNCIL TUESDAY 28 FEBRUARY 2012 AT DEVAUDEN VILLAGE HALL

COUNCILLORS PRESENT: M Powell, K Reece, J Williams (chair), N Knowland, A Duffield, E Hall, **IN ATTENDANCE:** C Martin (clerk), Andy Jones and Laura Redwood (PCSO), John Rowlands **APOLOGIES:** CC Bob Greenland, PC L Thorpe, A Williams, A Cooke.

1) OPEN SESSION

PCSO Jones informed the meeting of the recent incidents and said he would forward them by email for the clerk to attach to the minutes.

Mr Rowlands asked if the petition relating to the LDP, left at the last meeting, had been sent to MCC. Cllr J Williams declared an interest and left the room. Cllr Hall took the chair. Cllr Knowland said he had not understood that was what they wanted us to do with it. Mr Rowlands asked if it would be forwarded. It was agreed by the meeting that it could and the petition was handed to the clerk to forward to Martin Davies at MCC. Cllr Williams returned to the chair. Mr Rowlands asked about the community council's views on the proposed John Wesley memorial. He explained that Paul Matthews had asked Anne Jones of MCC to work with him on the project and she is currently investigating the legalities of siting it on the green. Cllr Williams asked to be at the next meeting with Mr Rowlands and Anne Jones and Mr Rowlands said he would inform Cllr Williams. Mr Rowlands then described the memorial as a resin made by Paul Ebrey of a bust of John Wesley. This will cost about £3000 and there would also need to be a stone plinth. Cllr Duffield asked who would be responsible for it and its insurance. Mr Rowlands confirmed it would be the hall committee. Cllr Duffield said it was important that all villagers are involved. Mr Rowlands agreed he would do this. He then went on to describe a digital storyboard about John Wesley and Devauden generally and Mike Chilcott from UCW Newport was working on this with him. He also said there were plans to have heritage village signs and that the old name for the village was THE Devauden and MCC are considering changing the village name. Cllr Reece said he thought this a waste of scarce resource and couldn't see the benefit. Mr Rowlands said the existing name could go on the heritage signs. Cllr Williams asked what the timescales would be. Mr Rowlands said he would like to have it done by 15 October to commemorate when Wesley preached. Mr Rowlands said that Mark Lloyd at MCC wants confirmation that DCC agree and would like a donation. Councillors instructed clerk to write to Mark Lloyd at MCC saying they support the memorial but can't agree a financial contribution at this stage but will consider it when there are more specific plans.
