MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 29 APRIL 2013 AT DEVAUDEN VILLAGE HALL

APOLOGIES:

1) OPEN SESSION

PC Thorpe presented the incidents for the month (see end of minutes). PC Thorpe then provided more information and documentation regarding the creation of the cold calling control zones. She informed the meeting that 70% of people in an area or street needed to be in favour for it to be put in place. Then it will cost £60 per sign to be put on lampposts at the entrance to the area/street.

2) CONFIRMATION OF MINUTES

The minutes of 25 March agreed and signed by JW and CM.

3) MATTERS ARISING

- **3.1** Report from CC Greenland re; domestic abuse, clinical futures and welfare reforms see county councillor section below.
- **3.2** Telephone Kiosks X2 Connect have forwarded a pro-forma invoice for handles, glass etc. see finance section below. Cllr A Williams will find out how the community would like to use the kiosk at Cobblers Plain.
- **3.3** Grass cutting Cllr Rowlands reported that the frequency of cuts of the smaller greens would not make any difference to the price. Meeting agreed to retain the current cutting schedule.
- 3.4 Kevin McElroy put forward a proposal for the funding of the defibrillator to Hood Memorial Hall who were enthusiastic. He reported he had spoken to the supplier and they are happy to attend events to explain the equipment. KM said he was working with the Hall Committee to set up events one at the village fete and another in an evening to raise funds and awareness. He requested that the Hall Committee wanted to know how much funding would be available from DCC. The meeting agreed an £800 commitment towards the cost and the events should be publicised across the whole community including Itton.
- 3.5 Highways form (sent 28/2/13) received back from MCC.
- 3.6 Waste and recycling changes. Notified by MCC that an officer/councillor will attend the May 20 meeting. However as this is the AGM it was agreed that clerk will contact MCC to change the date to the June meeting at Itton where there is more space. Clerk to contact MCC. It was also decided that CC Greenland would ask a representative from highways to come to that meeting to discuss ongoing issues with the speed of response.
- 3.7 Dog Waste bins have had replies from Clerks in Caldicot and Magor. Cost of one bin appears to be about £200. These councils pay £3 per week per bin to have them emptied by a waste company based in Lydney. It was agreed not to pursue this at the current time as dog owners should be responsible for their pets' waste and take it home with them to dispose of. Clerk to investigate cost of no dog fouling signs.
- **3.8** Outstanding highways issues CC Greenland reported back on the flooding issue at Wesley Way to say that the hold up is that MCC are waiting for permission from a landowner to put in place a soak away into a local stream. If that is not forthcoming there could be a much more expensive alternative which would then have to be added to the list of priorities.

Clinical Futures Llanfrechfa critical care unit – Local Health Board's view is if you don't go ahead soon could lose funding and the consultation is ongoing.

Welfare Reform – from 1 April there are Welfare changes whereby people are having housing benefit reduced if they live in a property larger than their needs, to reduce overcrowding elsewhere. There is a discretionary personal payment fund for those who may face difficulties and housing support officers are working on this to protect the most vulnerable.
