MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 20 MAY 2013 AT DEVAUDEN VILLAGE HALL

1) OPEN SESSION

PCSO Jones presented the incidents for the month (see end of minutes) and distributed OWL information leaflets that will be put in the village shop. He then left the meeting.

Mr Maddocks suggested that the Community Council consider fixing the duration of post holders for example to 2 years. Chair thanked him for his recommendation and said that it would be considered at an EGM when the whole council could be present. Mr Maddocks then went on to describe the following highways issue:

60.13 – approximately 1.5 mile form Cobblers Plain telephone box, Wolvesnewton Road from Tredean Farm to 1st left turn to swallow Barn is pooling in the road that has left it rough and it needs attention. Mr Maddocks said he wanted to thank DCC and The Hall committed for the recent wonderful music festival. CC Greenland commented that there had been many positive things said to him about the festival.

Mr Caville asked about outstanding enforcement issue in Itton e.g. the entrance to the former Cottage Farm. CC Greenland said an appeal has been put in by the occupants of that property and it will now have to go to public enquiry. CC Greenland said he would check and report back.

Chair reminded the meeting that at the next meeting in June at Itton a representative will come from MCC to discuss waste and highways issues.

3) MATTERS ARISING

- 3.1 Telephone Kiosks JR reported that the Devauden kiosk was almost finished. The sandblaster will be doing Itton next month. Fred Richards has offered to paint it. There was a discussion about whether he could be paid or whether 3 quotes would be obtained. Clerk to check with OVW if it is possible to alter the standing orders to not require 3 quotes below a fixed amount.
- 3.2 Kevin McElroy reported that he had drafted a page for the website re; funding of the defibrillator. There will be a meeting in the village hall on Jun e and a giving account has been set up with an internet link for donations. CC Greenland has not had any replies regarding funding availability from Adventa but will look into this and the rural development fund and Local Health Board.
