### 1) OPEN SESSION

PC Thorpe not present but emailed the police report at the end of the minutes and PCSO Jones attended. He provided details of the new Forestry Officer for the area – Bob Mayo (07768596442). There is one green lane in Monmouthshire that can be used by off road bikes and it goes through the Cot, by Fair Oak Farm and then up through Bucklewood. PCSO Jones reminded the meeting that off road bikes must have plates and tax and insurance if using the Green Lane. Off-roading notices were supplied and will be put on the notice boards.

#### 7) COUNTY COUNCILLORS REPORT

BG responded to the request at last month's meeting regarding the ambulance response times – he had had meetings and made many representations but the response times have not improved. He suggested MCC writes to the health minister at WAG with examples and to lobby for improvements.
