MINUTES OF DEVAUDEN COMMUNITY COUNCIL MONDAY 25 NOVEMBER 2013 AT DEVAUDEN VILLAGE HALL

COUNCILLORS PRESENT: J Williams (chair), K McElroy, A Williams, N Knowland, M Powell, A Cooke **IN ATTENDANCE:** C Martin (clerk), CC Bob Greenland, Public (see end of minutes). Nigel Leeworthy and Alison Howard (MCC)

APOLOGIES: CC Bob Greenland, J Rowlands, PC Thorpe.

1) OPEN SESSION

Police report is at the end of the minutes – PC Thorpe and team sent apologies.

Cllr J Williams introduced Mr Leeworthy and Ms Howard from MCC who had come to talk about the biodiversity plan and verge cutting. Mr Leeworthy explained the Monmouthshire biodiversity and pollinator plan and that all verge cutting would be risk assessed with road safety as the top criteria. This means that the straight low risk sections of A and B roads would not be cut back as frequently. Any area with safety implications will be cut more often as is now the case. So some sections of A and B roads will not be cut in June/July but all verges will cut their full width in September/October. Ms Howard explained that this was to ensure the sustainability of pollinators as their numbers are dropping and expert advice has been taken at government level and with Gwent wildlife. Mr Leeworthy also talked about annual bedding sites and the introduction of wildflower mixes. Mr Maddocks asked questions about the September DCC minutes and Cllr J Williams read out the entire ward report for Cllr A Williams that related to verge cutting. Mr Maddocks asserted that leaving straight stretches uncut would cause problems and hazards and it may be that C and R roads will follow this pattern in future too.

Cllr A Williams explained that he brought this issue to DCC and MCC as he was aware that other areas have managed this very well and overall only 8% or roads will not be cut as now. Ms Howard informed the meeting that all community councils were invited to a presentation on these proposals which will then be presented at MCC on 23 January for approval.

Mr P Williams suggested there was an earlier cut in the spring to avoid damaging pollinators. Mr Leeworthy said they took advice from experts and the plan was based on this. Mr G Parry referred to road safety as a major issue and most farmers did a lot for wildlife and shouldn't areas like parks and churchyards be included. Ms Howard confirmed that this was being looked at as well.

Cllr JW asked if there would be any cost savings. Mr Leeworthy said would be a saving of £2-3,000 per year and savings further savings from doing less horticultural planting. Mr C Pritchard asked if this was only in Monmouthshire. Mr Leeworthy replied that was all over Wales. Cllr J Williams asked what the public would have to do to make representations. CC Greenland summarised that road safety would be paramount. Cllr J Williams thanked the MCC officers. Mr R Parry asked if DCC and MCC have power to make someone cut their hedge. Cllr J Williams explained that DCC could ask but then would refer to MCC who could issue notices. CC Greenland said there is a policy that MCC officers have to follow but this is currently under review.

Open meeting closed at 8 pm and the MCC officers and public left the meeting.

There will be 5 further meetings and community involvement may be the way to deliver some services.

Reported that Paul Williams is now heading a commission looking at future delivery of services in Wales and most likely thing to affect us will be proposals to join MCC with neighbouring authorities. Finally there has been a review of community council boundaries but in DCC case it is unlikely that there will be any changes although maybe some changes to the wards.

9) WARD REPORTS

KM – Reported that has approached Spectrum about putting a phone line in for the defibrillator for free and sponsor it. No response received yet.

JW – Requested that clerk adds the hedge cutting in village properties from the previous meeting to the ongoing list. Top of Well Lane on B4293 is a street light not working properly.

MP – Sign post down opposite Holly House School Lane Itton where it looks like a hedger has taken out the sign. Footpath from the end of school lane round Chepstow Park Woods is no access for disabled people. Clerk to email Shaun Pritchard to see if this is a requirement.

AC- There is no footpath sign leading out of the car park at Wern y Cwm and at the other end of the same footpath sign is damaged. Still no action has been taken about a sign to say no heavy vehicles at Ty Bettws Hill. Clerk to add to highways again.

AW – Hedge trimming on Well Lane – a layer of material was left on the road and is now compacted causing a hazard. Also land owned by Woodland.co.uk is restricting heavy vehicles as the hedge is so high.
