## 10. County Councillor's Report

CC Greenland advised that the planning application for a quarry at Clkedd-y-Tan Wood, recommended for refusal by DCC, had been approved by MCC as there were no planning grounds for objection. However, many of the comments against the application had been included in the conditions laid down with the approval including a severe restriction of the hours of operation to reduce inconvenience to local residents and the need for an environmental licence before work could start in order to protect dormice. It had been noted by MCC that work had started before a licence had been obtained and this had now been stopped.

CC Greenland had met recently members of the Boundary Commission for Wales. Although there were now to be no changes to the numbers of principal councils for at least the next ten years there would be some changes with a proposal from the Commission for the number of councillors in MCC to increase from 42 to 46 by 2022 because of the rural nature of the county. This increase was likely to lead to some boundary revisions. Under the rules introduced by the previous minister, community councils within MCC would be subject to review from 2017. The review would be carried out by MCC on behalf of the Boundary Commission and the number of community councils was likely to be reduced.
