# 1. **Open Session**

The police report for this period is at the back of these minutes.

# 2. Apologies

Apologies were received from CC Greenland.

# 3. Matters Arising from the Open Session

There were no matters arising.

# 4. Minutes of Previous Meeting

The minutes were approved, and signed by the Chairman.

# 5. **Matters Arising**

a. Minute 5a – KM had spoken with the company providing the monitoring service. It would appear that in the future all defibrillators should be registered with the The Circuit, a database developed by the British Heart Foundation. This will be introduced in Wales by the Welsh

Ambulance Service over the next few months and will replace the previous monitoring service. Devauden's defibrillator has been registered with The Circuit.

- b. Minute 5b JW had discussed the  $75^{th}$  anniversary of VE day with those attending Devauden Teas. They will be organising some event based on a 1940s theme with a date yet to be agreed.
- c. Minute 5d the Clerk still awaited advice from MCC regarding access for mobility scooters.
- d. Minute 5e MCC had contacted the resident at Itton Common and would now investigate the trees in front of Nos 3 and 4 Itton Common for honey fungus.
- e. Minute 8a MCC had advised that the owners were entitled to move the position of the wall without further consent within certain restrictions. This repositioning meant the track had to be moved which required permission; MCC had requested a new application for this permission. The case had been included on the latest Enforcement List.
- f. Minute 11a The Clerk had chased MCC for a response on this issue but had still not heard anything. In discussion it was noted that there was still occasions when several bags were dumped at the crossroads on non-delivery days. AC would contact the Flytipping department at MCC to see what could be done and the Clerk would continue to chase MCC to issue a notice to all local residents. **Action:** AC/NJ.
- g. Minute 11a GAVO had advised NK that correspondence regarding the competition would be distributed in March.
- h. Minute 11c –No potential community projects suitable for a grant from Viridor were submitted.

## 6. **Speeding**

a. The community at Llanfihangel Tor-y- Mynydd had met and discussed the DCC proposals, announced their support of them and had offered to help with any future discussions. KM would circulate the final draft to all councillors. If no comments he would forward it to MCC Highways department, seeking a meeting with them to discuss the proposals and how to take them forward. **Action: KM.** 

#### 7. Finance

- b. The bank reconciliation and financial report as at the end of December had been circulated, were agreed and signed by the Chairman. It was noted that a £100 cheque granted to Wolvesnewton Church last summer was still to be cashed. AW would check with BG what had happened to it. **Action: AW**.
- c. A quote for grounds maintenance for 20/21 had been received from MCC. Given the unreliability of the cutting of some areas during 19/20 it was agreed that further quotes should be obtained. **Action: AC/NJ.**

# 9. **Planning**

- a. DM/2019/02044 proposed single storey to the rear of the existing village hall at Hood Hall, Devauden. Cllrs Rowlands and McElroy declared a n interest in this application which, given the 21day rule, had been considered out of committee. Recommended for approval.
- b. DM/2020/00101 two storey porch extension to existing barn at Grange Park House, Trellech Grange recommended for approval.

# 12. Ward Reports

- a. JW was concerned that over the last couple of winters many of the catseyes installed a few years ago had been pulled up and there was now a requirement for more to be installed on the B4293 between Devauden and Itton. **Action: NJ.** In addition she reported the following from the recent OVW Area Meeting:
  - 1. apparently councils now required a certificate to confirm they knew how all dog waste was disposed of. DCC, like most councils, used Merlin Waste and, as no official advice had been received, the Clerk was asked to contact MCC to confirm what action was required. **Action: NJ.** 4

- 2. There had been some difference in interpretation by HMRC local offices on the requirement for taxing councillor allowances. OVW were investigating.
- 3. There had been a very informative presentation on creating energy locally by the Green Valleys Community Interest Company, giving examples of community vehicles, public charging points for electric cars, solar panels etc.
- b. AC had been disappointed in comparing two recent visits to Abergavenny and Chepstow. In particular, she was concerned that there was only very limited free parking available in Chepstow, unlike Abergavenny and indeed Monmouth. After some discussion it was agreed that the Clerk should write to MCC expressing DCC's concern. **Action: NJ.**
- c. JR produced a written quote for £145 from Fred Richards for the refurbishment of the benches on the Green. It was agreed to accept the quote. **Action: JR.** He also expressed his and others' concerns over the state of the former Masons Arms which was regarded as an eyesore in the middle of the village. The Clerk was asked to forward the Council's concerns to the owner and ask for urgent work to be carried out there. **Action: NJ.**
- d. AW advised that the drain on the R80 just west of the lane to Model Farm needed clearing; this had been raised in September. In addition, drains along the whole of the R80 from Cobblers Plain to the intersection with Church lane were blocked and, in particular, near Tredean Farm and Clydach Corner. **Action: NJ.**

## 13. Councillor Resignation

KM had forwarded his resignation to the Chair as he would be leaving the Devauden Ward. The Clerk would contact MCC to start the election process for a new councillor. **Action: NJ.** In accepting his resignation the Chair wished to record his gratitude and appreciation, on behalf of the Council, for KM's significant contribution over many years. In response KM also wished to record his thanks to all the councillors for their support and wished the Council all best wishes for the future.
