Public participation: The applicant reviewed the history of the application and the anticipated energy efficiency and money savings, that the site is non residential and in curtilage of the listed building. The Conservation officers visit, elimination of other areas for panels, the view from the PROW, weight loading, bat survey, and the storage battery, grant providers, green energy, the likely response of the conservation officer.

Matters discussed included: D2 'Promoting high quality and inclusive design – high quality sustainable and inclusive design that responds positively to and reflects the particular characteristics of the site and the identity of the surrounding areas well as taking into account climate change – consideration given to historic character'

D4 Renewable or Low Carbon Energy and Heat Generation projects – 'evidence that the scheme has been sited to address adverse impacts on the surrounding area as far as is practical for its effective operation. Balance between the adverse impacts on users and the extent of any direct benefits to the local area and community.'

D26 Historic Environment = 'Emphasis on the importance of the setting of the designated heritage assets as well as important views to or from the assets themselves.'

Preapplication advice — 'objection in principle -visually harmful to the setting'

Recommendation: Support - Unanimously agreed Basis: The application is in line with Local plan policies D4 and D26 and is sited to minimise visual impacts, the proposal is positive for the community in achieving fuel cost savings and keeping hire costs lower to encourage use.
