Minutes of the Planning Committee meeting held on Thursday 17th August 2023 at 11.10am at Badgworth and Biddisham Parish Hall, Bristol Road, Biddisham

Public participation: The applicant spoke and answered questions regarding application 03/23/00005. Matters discussed included visibility, type of business; aim of business; neighbours support; waste to be composted; the land is both agricultural and equestrian.

Proposal: Change of use of fenced agricultural/equestrian land to dog training,

including an extension to existing hardstanding area and flood lights

fixed to existing building

Matters discussed included: Public and Consultee Comments, access, runoff and permeable hard standing, waste management, lighting plan, noise and disturbance, vehicle movements, group sessions and shows, loss of agricultural land, road junction and increase in traffic, speeding, the floodlights to be pointed inwards for the access, no lighting on agility field, cumulative effect of traffic, dogs, drainage.

Resolution: Support

Basis: The Parish Council support the application but have the following concerns to be addressed as part of the consultation.

The increased traffic on Biddisham Lane and at the junction of Biddisham Lane and the A38, particularly with regard to the permanent speed limit and recommend that highways formal response is sought and considered.

The Parish Council understand that the agility field will not be lit however It is recommended that a lighting plan and conditions are included to control any impacts on the surrounding area.

The waste management plan should be conditioned.
