Proposal: Erection of in industrial building for B2, B8 and E(g)(iii) uses on site of

existing (to be demolished)

Matters discussed included: Public and Consultee Comments; highways and access, visibility splay, noise, lighting, hours of use, visual impact, scale and character of location, size and scale of the building, additional traffic, attenuation tank, D15 economic prosperity and D16 safeguarding existing employment land and buildings, access and volume of traffic, lighting plan, concerns over asbestos in roofing, Environmental Health and noise control.

Bio Net Gain:

Resolution: Support. Unanimous.

Basis: Due to the size and scale of the new building mitigation should be considered for runoff water in addition to a soakaway. A lighting plan for external lighting, other than timed security lighting, should be required. Concerns that the roofing could be asbestos, which should be removed in accordance with regulations.
