West Mill Rise Street Lights In response to a query, the Parish Council confirmed it does not have powers to enforce planning conditions, these can be followed up by the Planning Enforcement Team at ERYC if required, it also confirmed Commuted Sums Funds are for the provision of play and sports equipment.
