7. Community Matters

7.1 – The Shore Sweepers / Graham's Point

The plants are growing successfully in the sign tub at the end of the road. A big thank you to all the residents who tend tubs along the road for the community.

7.2 - Shore Villages Flooding Issues

Steve said that it would be useful over the next weeks to log any flooding issues that are seen in the area. Flooding in Midge Lane. JH will repost this to ABC as it is possible that the culvert along the road and the runoff tracks need cleaned.

A residents said that water is flooding down Strone Brae from Westfield and above.

Flooding issue also at Blairmore. We need to log issues so we can approach FLS and ABC to help identify problem areas. GH said that walkers could take photographs of the sediment traps further up in the forestry to show if they are needing cleaned.

7.4 - Community Resilience

Steve says that he now has a great committee working with him on this area. To do this we need to raise money to set up a refuge area. He is hoping that we will have something ready for the end of the year to give out to people with advice on how to deal with potential situations

7.5 – Bus service Changes

This comes under the transport forum area. There is concern about the changes of the bus provision from West Coast Motors for local businesses, JH said that Ardentinny and other areas like Hunter's Quay and The Holiday Park have also been affected and areas in Dunoon itself. Diane described the difficulties that Clachaig is also facing with lack of bus provision.

Councillor Sinclair will raise this to the area committee which he says is a good time to raise these difficulties with the transport officers and West Coast Motors. Also, as there is a public question time at the area committee, this is a good time for community councils to raise questions on these difficulties.

Diane Nicholson said that perhaps community councils should be consulted about changes to the bus timetables before they are ratified. Diane to attend Transport forum meeting on 24th November.

8. Discussion with Argyll & Bute Councillor(s) and National Park Representative

8.1 - Argyll & Bute Councillor(s) Update

A multi-agency meeting was organised with the owner of Dunselma and representatives from Argyll and Bute Council and Loch Lomond and Trossachs National Park.

The following report was given to Kilmun Community Council:

Following representations from ClIr Gordon Blair and local stakeholders, Roads officers were asked to provide advice on potential short-term measures to improve access along the private road serving the Golf Club. The golf club, the owner of Ardno, and residents have indicated a willingness to cooperate on remedial works, including contributing towards material and labour costs.

The road forms a private access serving a small number of properties and the golf club. It is not part of the public road network and, as such, maintenance responsibility rests with the owners. We visited the site last week to assess its condition and identify proportionate remedial options.

Findings

- * The private road extends for approximately 200 metres, with two particularly poor sections totalling around 70 metres, but is passable in its current condition
- * The surface is affected by a build-up of compacted debris, loose stone, and moss. This accumulation makes existing potholes appear deeper and traps surface water.
- * Effective repair would first require the existing debris to be scraped off back to the original road level using an excavator.
- * Based on current conditions, approximately 50 tonnes of road planings would be required to restore the surface.
- * For best results, planings would need to be laid in dry, warm weather and mechanically compacted using a road roller, rather than a vibrating plate.
- * Roadside ditches also require clearance to reduce ponding and improve drainage, and this step is critical to any remedial works lasting.

Next Steps / Recommendation

- * The road carries relatively low traffic volumes, serving only the adjacent properties and the golf club. Any remedial works should therefore be proportionate to its use and rural setting, focusing on reinstating safe and functional access rather than full reconstruction.
- * Should local parties wish to proceed, the Council can supply road planings at £10 per tonne on a transactional basis.
- * Works should be carried out by the property owners or their appointed contractor, with appropriate plant to ensure proper compaction.
- * Officers can offer informal technical guidance, but ongoing maintenance responsibility remains with the owners.
- * In the longer term, a modest programme of resurfacing should be considered.
 - Residents asked if there is a timescale for a programme of work.
 - A resident commented that if this situation continues there will not be a golf club in 6 months.
 - It was commented that it is the executives of the golf club and not the members who have a right of access on the road past Dumselma.
 - A comment was made that the building will still have listed status even although it does not currently have a roof.

Tynshandon

When the building control. officers visited the Dunselma Stables building they also looked at the Tynshandon. They deemed the building to be in a satisfactory condition. However, many residents who live near this building, passing pedestrians and traffic continue to be very concerned about debris falling from the roof and building. This situation continues to need to be carefully monitored.
