5. Police Report

6. Planning Applications

The bottom of the building will be retained as a hall area. There will be flower tubs marking the dog walk path past the building.

7.1 – The Shore Sweepers / Graham's Point

Bulbs and cyclamen have been bought for the tub at the end of the road and at the Strone sign which the Shore Sweepers are also going to manage.

Janet Holm asked if the Shore Sweepers could have a donation of £100 from the Kilmun Community Council funds for buying plants. This was agreed by the committee.

A question was asked about why the play area at Graham's Point was cordoned off. As this belongs to ACHA. Janet Holm will email them to ask why this is.

Question asked about who was doing the flowers in Blairmore. Janet Holm thought it was Blairmore Village Trust. Janet Holm will email Blairmore Village Trust to find out if they are still managing the flower pots.

Steve Abbott asked about an email we had received about using pay back workers, but Janet Holm explained that doesn't really work for Shore Sweepers. HELP usually maintains the willow tunnel at Graham's Point.

7.3 - Defibrillators / Training

Steve Abbott said that there will be a Heartstart session on Saturday the 11th of October between 11am and 1pm at Younger Hall, Kilmun.

Details of this will be circulated by Kilmun Community Council via their website. As Steve Abbott is now the only Heartstart responder between the Cothouse and Ardentinny, he is worried that, if there was an in an incident, he would be really stretched. He would appreciate it if the community could come along and this could help support the provision. Heartstart are going to try and run another session at Blairmore Hall probably in November.

Steve also reported that all the defibrillators have been checked and have not needed to be used.

Also, Steve Abbott said that he had seen that there was an emergency blue light ambulance last weekend which was looking, with difficulty, for a property it had been called to. He said it was helpful for people to use <u>What Three Words</u> which would help services to easily find the address of a call out. Information about this will be put on the news section of Kilmun Community Council's website.

Steve also said that he still has a defibrillator at his home which needs to be allocated. Janet Holm will clarify further whether it can be fitted on the Strone Primary building which still has electricity connected to it. It was agreed that this was the best position for the residents of Westfield and Dunselma areas. As there was a defibrillator on the school previously perhaps the connection is still there

7.4 - Community Resilience

The homeowner plan is basically common sense and when the committee has approved it can be distributed to the community.

The community resilience plan is more difficult and complicated to compile. Steve thinks that even if the plan is well put together unless the community engages with it and takes it on board it will be meaningless. Steve discussed with the residents present the options which could be used as emergency refuges in the event of emergency situations.

9. Current Issues

9.1 - Meteorological weather mast, Giant's Burn Wind Farm and Inverchaolain wind farm (scoping)

Several Kilmun Community Councillors listened to this planning hearing remotely. The meteorological weather mast planning application was passed by Argyll & Bute Council Planning with the amendment that it was not to be seen as a precursor for them approving of a wind farm.

As a statuary consultee an objection was submitted to energy consents from Kilmun Community Council. Kilmun Community Council had decided to be very open with our community, and thus the objection is published on our website and in now in the energy consents website too. Our objection was from our community, not just the Kilmun Community Council committee.

Mark Borland thanked everyone on the committee who worked collaboratively to produce the document through suggestions, knowledge sharing and peer review. Also, thanks were given to Neil Hammett, Gordon Holm and help from Save Cowal Hills who had also contributed to some of the latest research information.

Gordon Holm also said that the work that Neil Hammett, who is very involved with work at the Holy Loch Nature reserve, is being shortlisted as a 2025 finalist by the National Biodiversity Network, for an award for wildlife recording.

9.2 - SSE power lines Dunoon 132kV Overhead Line rebuild Project.
