7.1 – The Shore Sweepers / Graham's Point

7.4 – Community Resilience

Steve Abbott has registered Kilmun Community Council with the Argyll & Bute Council funding website. He has reviewed the current funding streams available for anything which is relevant at present. Steve requested support from the Kilmun Community Council committee to review and investigate potential funding options.

Steve Abbott has obtained and itemised the current emergency bag, which was stored in Younger Hall, Kilmun, and is reviewing the contents to see what is useful as well as what additional items it should contain.

Steve Abbott has downloaded and reviewed the Ready Scotland emergency planning documents, the Ardentinnny contingency plan, Largs contingency plan and will review with regards what can be re-used for the Kilmun Community Council resilience plan.

Steve Abbott and Mark Borland are continuing to investigate and catalogue the resources available in the area in order to ascertain what is individual responsibility, what is Community responsibility, what is Argyll & Bute Council responsibility and what gaps there may be.

Steve Abbott has also met with Sue Rule (Blairmore Hall Committee at the time of the meeting) and also visited Strone Church, Younger Hall, Blairmore Hall and following up with Diane Macdonald (Benmore and Kilmun Development Trust).

A resilience plan had been written previously for Kilmun Community Council in 2016 which Steve Abbott proposes to use as the template for the refreshed and updated plan.

8.3 – Forestry & Land Scotland (Submitted via email after the meeting)

Puck's Glen June 2025

Forestry & Land Scotland are aware of the impact of the closure of Puck's Glen on the wider community and are working to come up with a longer-term resolution to the management of the site.

Due to the topography and geology of the gorge the trees on site are at a constant risk of falling in and blocking the gorge, making it unsafe for visitors, and taking huge resources to remove and remediate any damage to the path and multiple bridges that are on site. Due to the more extreme weather events, we are experiencing along with the maturity of the tree crop, these incidents are becoming more frequent.

Whilst the gorge remains closed we are working to clear the track from the car park to the forest road above the Glen, so that people can enjoy a loop between Puck's Glen and Benmore on a slightly diverted Black Gates trail as per the temporary route card attached. Please heed the safety signage on site. This should be available early July, please check our webpage for updates:

We are looking at longer term options to reduce risk of these incidents, and secure the long-term future of the site, but are acutely aware that removal of the at-risk trees will dramatically change the visitor experience that has developed during their growth. We are currently working internally to define the aims and objectives for the site long term, which fit in with our Land Management Plan for the area.

We will then look to identify partners to take the project forward. We would be happy to hear from potential partners who may be interested in getting involved

8.4 – Strone Primary School & Strone Parent Council

Kilmun Community Council received an email from Councillor Sinclair which stated that he has written to the relevant officers and Councillors regarding Strone Primary School and enclosed a reply from the Executive Director for Education Douglas Hendry (below).

“I'm not sure how much Fiona would be able to say to you at this point in time, as Depute Policy Lead for Education, because from the Education Service's point of view there is nothing which would need to go to the Policy Lead/Depute, or to the Community Services Committee, at this point in time.

I can say at this stage, and I hope you find it helpful, that the intention is to bring forward a report in relation to Strone Primary to the Community Services Committee's meeting in August which will hopefully provide clarification of the position going forward.”

Councillor Sinclair noted that it does look like a paper will be going to the Community Services Committee in August which will give a better picture of the situation. Councillor Sinclair will keep a watchful eye on what is happening.

Councillor Sinclair also raised the matter at his Council Administration Meeting yesterday and had a phone call with Councillor McNeilly who is shadow Policy Lead for Education.

9. Current Issues

9.1 - Meteorological weather mast, Giant's Burn Wind Farm and Inverchaolain wind farm (scoping)

Save Cowal Hills had a meeting with Residents and the Gourock Community Council, and they are also in opposition.

As Councillor Sinclair was not in attendance, there was no follow up on his previous action to provide an update from Argyll & Bute Council. This action will be carried forward.

Following the meeting, an email was sent to Kilmun Community Council from Statkraft as a follow up to the 2nd round of exhibitions which took place in April 2025 and online consultation that took place in March 2025. Full email included below:

“Dear Members of Kilmun Community Council,

I am writing with an update on the Giant's Burn Wind Farm proposal following our second round of public exhibitions held in April 2025.

As you may recall, we held in-person public exhibitions on the 1-3 April, at five different locations, Dunoon, Kilmun, Sandbank, Innellan, and Cove. We also held an online consultation from 31 March – 21 April, for anyone unable to attend the physical events or who preferred to go online. We wish to thank everyone who took the time to come and meet us and/or returned the feedback form to let us know their views on the project.

Since the exhibitions, we have been compiling responses to everyone who returned a reply card and indicated that they wished to be updated on the project. These emails will be arriving with them shortly. For anyone who responded to the reply cards but did not 'tick' that they would like a response, we have been unable to write directly in-line with GDPR legislation, however, we have a FAQ section on the project website with main themes and questions asked on the project.

Please find attached our Consultation Report, which provides a summary of the feedback we received at the exhibitions. We will upload the Report to our project website and are sharing it with local and neighbouring community councils and elected representatives.

9.3 – Community Council Ferry Group

Alan Stewart from the Community Council Ferry Group has contacted Pippa Milne at Argyll & Bute Council and explained that they were going to be trying to take over the Dunoon linkspan and the reasons behind it. They had a fairly positive response. Alan has sent Pippa more details and have requested a meeting with council officers. Jenni Minto (MSP) has been in discussion with Pippa and supporting this move.

While the group have not yet prepared an invitation to tender to send out to potential operators, Alan has emailed a couple of companies that he thought may be interested in taking on the route. He has had a response from one company that may get somewhere, and the response from the other is not an outright no. Alan has provided more information to both companies and will update the group as he receives responses

David Clough (Dunoon Community Councillor) and Alan met with Chris Martin of the Dunoon Observer and since the previous Kilmun Community Council meeting, an article reflecting the above has been published.

The next stage will be to prepare the outline of a tender document. David Clough (Dunoon Community Councillor) has had many years in procurement and will hopefully guide the group through that part of the process.

10.3 - Other

Mark Borland raised the post circulating on social media by Neil Hammett regarding Argyll and Bute selling / passing over the dumping area next to the Sandbank nature reserve at the end of the Holy Loch and asked the committee members if they could take a vote to support this endeavour as it provides benefit to all residents of the Holy Loch area. Kilmun Community Council committee members voted to support this proposal and Gordon Holm agreed to contact Neil Hammett to let him know of our position and find out if there is anything Kilmun Community Council can do in support.

A question asked from the floor about the report in the Dunoon Observer concerning raw sewage flowing into the Holy loch. There followed a general discussion around the septic tanks that were installed along the Shore Road and that there was the possibility of another one being installed. Nicola Stewart agreed to contact SEPA and investigate this further.

There was a final comment from the floor regarding loose roof tiles that could potentially fall off the roof of the flats at the bus stop at the bottom of Strone Brae. This was highlighted as a potential danger and Mark Borland stated that he would contact ACCA to investigate what mitigating actions were being taken, if any.

Puck's Glen Gorge (closed)



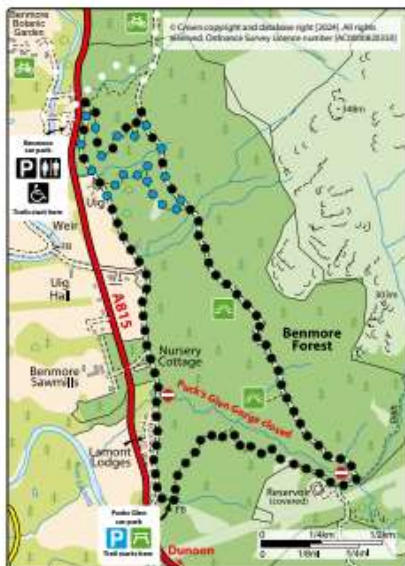
Following extensive storm damage we have taken the decision to close Puck's Glen gorge for the 2025 season.
