NOTES TO THE ACCOUNTS

1. Basis of Accounting

These financial statements have been prepared on the receipts and payments basis in accordance with the Charities & Trustee Investment(Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2. Nature and Purpose of Funds

Unrestricted funds are those which may be used at the discretion of the Trustees in furtherance of the objectives of the Charity; the Trustees maintain a single unrestricted fund for the day to day running of the Association and for all activities of the Association. Restricted funds may only be used for specific purposes; at year end the Association was holding £1016 for the Sea Eagle Project, £2016 for the Playpark Project, £2385 for the Gaelic Placenames Project and £1536 from the Mary Hamilton Trust.

3. Related Party Transactions

No payments or expenses were made to any Trustee during the year. No transactions with Trustees or connected persons were made during the year other than reimbursement for items purchased on behalf of the Association.

4. Grants Received 2018-2019

The Gaelic Placenames Project received £2400 from Bord na Gaidhlig.
