63-12-22 IW wanted to establish how to proceed with the footpath project that Chris Ventriroso had been working on and what the process was with regards to getting the paths registered as footpaths now that CV had identified them. TN advised that she had given CV details to Adam Philips at LDNP Area Ranger and also Nick Thorne Senior Rights of Way Officer. Nick Thorne had been asked to send us a parish map with numbered footpaths. SG suggested that the next course of action would be for CV to come to the next parish meeting and the Parish Council could then look to support the applications of registering the footpaths. IW to contact CV to invite him to the next meeting.

Bridleways – MG said Bridleways and footpaths had been destroyed at Irton Pike and Parkgate he wanted to know if the Parish Council were notified of the bridleways being demolished. TN replied that the Parish Council did not receive any notification. Irton Pike was opereated by the Forestry Commission whilst it appears that damage at Parkgate had also been also been caused by the Forestry work with 2 ft deep slurry in places. TN said there was a complaints process for the Forestry Commission and Forestry England she would also

contact Nick Thorne and establish if there was a way of being notified in advanced of such works so that it could be placed on our website/WhatsApp for the benefit of local residents.

Gritting – IW expressed concern that local roads had not been gritted. MG said that he had seen the Gritters coming through from Gosforth. TN said that there was an internet link to Highways where parishioners could raise their concerns. TN would put this link on the WhatsApp group and a numbered list of the roads.

64-12-22 SG Letter from local worker that had been delivered to many households explaining how he cuts all the hedges etc. across a vast area and does not get paid by the council, he was therefore requesting £25 per household. SG said that Eskdale Parish Council were discussing this topic at their January 2023 meeting. MG stated that if the individual was paid for the work that he did then he would need to have Public Liability Insurance. TN confirmed this. Discussion took place as to who was responsible for the cutting of hedges on roadsides. SG to make contact with Eskdale Parish Council.
