## **Cold Ashby Parish Council**

Draft minutes of ordinary general meeting of the Parish Council held on Wednesday November 5th, 2025, in the Playing Field Pavilion at 7.30p.m.

**Present:** Councillors Bailey (RB), Harpham (NH), Peel (AP), Alex Taylor (AT), Fiona Taylor (FT), Rachel Williams (RlW) and Richard Williams (RdW). Councillor Christine Ware (WNC, CW), P.C. Kevin Lumbis (Northants Police), Aidan Gibson (Immediate Justice Programme). One member of the public. Jonathan Ward-Langman (Clerk, JBW-L).

**25.11.01 - Apologies:** there were none.

**25.11.02 – Minutes of the General Meeting of the Council held on Wednesday October 1**<sup>st</sup>, **2025.** Approved, subject to amendment of 25.10.12 to respond to query regarding nature of CCTV at the Black Horse (i.e. domestic or commercial). (*Proposed FT, seconded NH, unanimous*). N.B. it would appear that the ICCO website has been updated since the query was raised.

25.11.03 - Matters arising: none.

# 25.11.04 - Open forum: to receive and discuss matters raised by members of the public present at the meeting.

- A Member of the Public noted the passing of Terry Smith a former CAPC Councillor. The PC expressed its condolences to his family.
- CW reported on:
  - o WNC Budget setting.
  - o Suicide Prevention (see links, on CAPC website).
  - o Changes to Domestic Waste service

**25.11.05 – Presentation on Immediate Justice Programme:** Aidan Gibson BA MSyI Immediate (Community) Justice Manager gave a presentation about the programme which was well received. To be discussed at the Council's December meeting. (*Action Clerk*).

#### 25.11.06 - Accounts:

- Members approved the attached accounts for October 2025 and authorised the payments listed at Annex A. It was agreed that Npower bills should be paid by Direct Debit. (*Proposed FT, seconded AT, unanimous*). (*Action Clerk*).
- The Clerk updated members on banking arrangements and the switch to an account with Unity Trust Bank. (*Action Clerk*).

**25.11.07 – Budget/Precept Planning:** The Council considered the Clerk's report and agreed:

- The precept is unchanged at £12,000 for 2026-27.
- The Budget for 2026-27 attached as Annex B was adopted.

- Cemetery charges to remain unchanged, subject to review (see Annex B).
- £12-15,000 to be transferred from the main account to a savings account that bears interest when the Council transfers its Bank Account.

Approved unanimously, proposed RdW, seconded AT. (Action Clerk).

### 25.11.08 - Planning matters:

- The Outcome of appeal APP/W2845/W/25/3366285, Black Horse, Main Street, Cold Ashby NN6 6EL (original application 2024/2784/FULL Change of Use) was noted. RdW reported that he understood sale of the Black Horse to Steve and Jo Varley (former owners) was being negotiated.

**25.11.09 – Cemetery regulations:** the Clerk reported; discussion was deferred to the December meeting. (*Action Clerk*).

**25.11.10 – Scramblers, Bridle Lane and fly tipping J1 A14:** CW reported that the site at Junction 1 is now subject to a Community Protection Order. Gates had been installed, but it was reported that these had been broken. WNC officers are monitoring; problems to be reported on 0300 126 7000. P.C. Lumbis reported that the Police are also monitoring and have been involved for several years.

The Parish Council expressed its gratitude to the Police for getting the abandoned car on Main Street removed.

### **25.11.11 - WNC Parish Conference:** FT and AT reported:

- Traffic calming, especially enforcement of 7.5 ton limit. Email to be sent to WNC. (*Action AT and RdW*).
- Neighbourhood Planning; deferred to December meeting (Action FT).

### 25.11.12 - CCTV at the Black Horse. Discussed at 2.11.02.

**25.11.13 - WNC Developer Contributions Consultation:** Noted; all Councillors to respond if they wish. (*Action All*).

**25.11.14 - Post:** to note and/or discuss items of correspondence with the Council not considered elsewhere on the agenda.

- Street naming consultation: letter received re land off Main Street/Stanford Road (SN/2025/0158). There was no agreement about a suitable name, so the Parish Council will express no preference.
- CIL. CAPC will receive £5,790.53 from the development; WND/2021/0015 Land at Main Street/Stanford Road, Cold Ashby. Allocation to be discussed at December meeting. (*Action Clerk*).
- Application for grant for defibrillator training from Village Hall Committee to be discussed at December meeting. (*Action Clerk*).
- Speed sign battery replacement. Discussed. RdW to investigate. (*Action RdW/Clerk*).
- WNC SWEP email contact list; agreed that CAPC should be removed from list.
- Climate and Nature Champion (NCALC): volunteer still to be identified.
- Defibrillator check: RB confirmed that he undertook these each month.
