**25.09.01 - Apologies:** Councillor Christine Ware (CW, WNC).

**25.09.02 - Minutes of the General Meeting of the Council held on Wednesday August 6**<sup>th</sup>, **2025:** approved unanimously, (proposed AT, seconded NH).

## 25.09.03 - Matters arising:

- RB confirmed that he would take a reading from the water meter at the cemetery.
- The Council continues to seek a volunteer from the community to take on the role of Climate and Nature (CAN) Champion.

## 25.09.04 - Open forum:

- A member of the public queried whether reservation of plots at the cemetery was permitted. Councillors confirmed that it was not.
- A member of the public noted that lorries had been parked at Stanford Close for some time. It was believed that they were connected with building work.
