Minutes of previous meeting held 21st May 2014

The minutes of the previous meeting were agreed as a true record.

Election of Officers

Cllr English nominated as Chairman by Cllr Birnie, Cllr Clark seconded, agreed.

Cllr Burn nominated as Vice Chairman by Cllr English, Cllr Brown seconded, agreed.

Welcome to Co-Opted member Paul Barton

Cllr Barton welcomed as a member of Hedgeley Parish Council.

Opportunity for members of the public to raise any matter on the agenda

No members present.

Declarations of Interest

There were no Declarations of Interest

Matters Arising from previous meeting

- Sand bags had been purchased and stored behind sand container.
- Still no word from John Taylor as regards speed signage funding, and no results available from NCC speed survey
 carried out. It was hoped results would be more effective than community Speedwatch, and Northumbria Roads
 Safety Initiative could then be contacted. 10% of drivers on the road outside Breamish Hall had been caught
 speeding.
- There are problems with houses along Crawley Dene where plaster work is starting to crack as wagons drive along, residents had contacted NCC who indicated no funds to carry out alterations. It was agreed the PC would contact NCC as inappropriate methods had been carried out to lay the ridges, causing vibrations to housing. NCC had wished to place speed rumble strips but were refused due to the same problem. When slowing down over the bridge to 40mph cars are witnessed overtaking vehicles. Cllr R Burn to contact J Taylor regarding speeding survey results.

- Grass had been cut in the community garden and clearance works carried out, with rotovating work to be carried out to bushes in the stream. There is an issue with steps leading down to garden Sid had carried out a temporary repair, and will carry out further repairs to concrete steps and forward bill for this work to PC, it was agreed this work would be carried out. The fence around the well also requires fencing off as a matter of urgency and Sid also prepared to carry out this work, agreed. Hedgeley Estate should be made aware of the danger of allowing general public to use the land, ClIr English to inform J Carr-Ellison. There had also been a proposal to make a feature of the well, and there were problems with the tree used for the Christmas lights with a suggestion to cut the tree down, place a mounting hole, and use a donated tree on a yearly basis. Further suggestion to fence off the community garden and hold barbecues.
- It was agreed the village would be aesthetically better if grass verges were cut in all areas, J Brown to ask J Frater for a quotation for this work, and then go ahead if cost reasonable.
- North East Concrete had not yet sent road sweeper out to attend to site, it was agreed to contact NCC Enforcement Officer as a condition of their contract, which had previously been done and J Taylor County Cllr had looked into.
- No action on signposts, R Burn to contact J Taylor NCC.

- PNE Wind Ditchburn Wind Farm proposal to carry out consultation with neighbouring parishes, with two rounds of public exhibitions for the project, and a dedicated project website set up. Cllr Barton against onshore wind farms, believing they are not green and create more greenhouse gases. It was agreed to identify issues, as it is an area of outstanding beauty, however renewable energy is important but needs balanced against the disadvantages. Cllr Barton to look at website and create proposals.

Parish Plan

Suggestions had been put forward: to fence off community garden and secure the well; action to subsidence in front of the Plough; continuing to plant daffodils on verges on an annual basis, and should this be extended to Beanley and Bolton? However with the number of residents in those areas they could make their own decisions. With the interest shown in the community garden, it was agreed to invite Sid to the next PC meeting and also involve J Carr-Ellison as landowner after proposals had been discussed

Defibrillator

The clerk had become aware regular checks should be carried out to the defibrillator, P Barton happy to carry out these checks, and would speak to person who installed structure and North East Ambulance Service.

Any Other Business

- M Clark reported the footpath in Bolton requires remedial action and is crumbling near to the churchyard. Clerk to contact NCC.
- No reply had been received from NCC further to concern regarding the wagon overturning with radioactive load it was agreed clerk would recontact NCC.
- Further to NCC speeding report, and subsequent request for three mirrors, which are the PC's responsibility to purchase and erect such structures, Cllr Burn to look at costings.
- South side of Powburn requiring road maintenance. It was agreed a list of items requested to NCC to be kept on record.
