Cllr Wilson proposed Cllr Burn as Chairman, Cllr Birnie seconded, carried.

Cllr Burn proposed Cllr Wilson as Vice Chairman, Cllr Smailes seconded, carried.

22/16 Declarations of Interest

Cllr M Clark declared an interest in local wind farm proposals.

23/16 Police update

No police presence.

24/16 County Cllr update

County Cllr not present.

25/16 Minutes of previous meeting held 2nd February 2016

• The minutes of the previous meeting were agreed as a true record.

26/16 Matters Arising from previous meeting

- K Cairns had contributed funding of £2,000 towards village hall improvements, with total funding received now at £20,500. If a community group obtains funding for improvements it can be paid into a Parish Council bank account, the PC then order the work/improvements and are able to reclaim the VAT, however as Hedgeley PC do not have vast funds, this would need taken into account as there would likely be a deficit until VAT could be reclaimed.
- Cllr R Burn had inspected drains in the parish, however County Council had not cleared in at least three places, with streams travelling down hill and under gullies on A697, and in adverse weather drain spills straight onto road. Photographs had been forwarded to County Council. Hillside also saturated with water running into road and suggestion of a French drain installation.
- Concrete lintels directing water into drain placed on Thrunton bank had appeared to have cured that problem and details forwarded to K Cairns which could be of use in this parish.
- Cllr D Smailes had spoken to parent regarding pupil waiting for bus and they were to contact K Cairns directly.
- Roof tiles had been attended to on abandoned property in Powburn.
- Table tennis club well attended.
- Cllr R Burn had spoken to J Carr-Ellison regarding the Plough, who had confirmed he had employed negotiators to deal with Punch Taverns, and pub would then require extensive upgrading.
- Cllr R Burn had applied to carry out training to use speed gun, but had not hear anything further.
