2020/04 Minutes of previous meeting held Wednesday 4th December 2019

The minutes of the previous meeting held on Wednesday 4th December 2019 were accepted as a true record.

2020/06 Matters Arising from previous meeting held Wednesday 4th December 2019

2020**/05/01** Works to well

Material had still not been delivered, however Cllr D-Carr Ellison maybe able to source alternative stone, with approximately 20 tonne required.

2020/05/02 Play area

Play area repairs had been completed; replacement dog fouling signs to be erected; mole catching carried out.

2020/05/03 Parish drains

Environment Agency had stated the burn running through Powburn is not a main river therefore they have no powers to carry out any work and the responsibility would be with the riparian owners. If the bridge is affected then Highways England would look into the matter. EA advise informing NCC and the land owners, and depending on the exact location, also informing Highways England. It was agreed to wait until warmer weather before works are actioned, with ClIr Brown to speak to contractor who could carry works out. Inspection had been carried out to drains at bottom of Playwell Road with gullies cleaned, however further inspection to be arranged due to broken pipes discovered at the location and also at the garage. Concern was raised with drainage problems on A697 within Edlingham parish. Drain behind railway line running parallel is the land owners responsibility and no action had yet been carried out – further to this County Council would then clean the road. County Council had previously confirmed the Sump in play area is cleaned out on an annual basis to alleviate problems and had provided photographic evidence of this. ClIr J Brown of the opinion the County Council gulley sucker had swept debris into drains.

2020/05/04 Traffic safety scheme – to receive update

Gateway signage had been erected; proposed start date for Bolton and Beanley gateways 10/2/20; flashing speed limit signage ordered. Clerk to contact R Mckenzie regarding "thankyou for driving carefully signage," with comment received this should be moved to signage at North end. At the original discussion between PC/NCC an additional street lamp past the garage had been requested - Clerk to enquire if this would be possible.

2020/05/05 Transportation of nuclear waste – this refers to radioactive waste

Clerk had spoken to company who had explained only the miniscule lower level radioactive waste is transported under certain regulations on A697, with granite worktops containing similar levels of radioactive material to that transported. Specially trained drivers transport waste on the A1 which contains material from oil rigs, and agreement is required from the Environment Agency with waste carried in drums and workers wearing doseometers.

Notice of Arquiva's Smart Meter Network, proposed installation at Northbound Grass Verge A697, opposite Hedgeley, being a government programme to rollout smart electricity and gas meters to homes and small businesses across Great Britain, with planning application to be submitted.

2020/11 Review of Internal Auditor and Internal Controls

It was agreed to re-engage the current internal auditor, and Internal controls were deemed sufficient for the present needs of the Parish Council. Clerk reminded Cllr's all payments should be listed on the agenda prior to the meeting.

Employers liability and public/products liability currently £10,000.00; professional risks, asset and income protection, benefits and other insurance included; defibs covered at £5,000 and property covered on an all-risks basis, and the policy was agreed sufficient for the present needs of the Parish Council.

2020/15 Northumberland County Council – Consultation on library services

Northumberland County Council were carrying out a consultation on library services with survey available on-line https://surveymonkey.co.uk/r/NCCLibraryConsultation. The mobile library service visits the parish, and information session is to be held in the Breamish Hall as regards users completing the survey, which is also available as a paper copy. It was resolved Clerk would submit written response stating the mobile service is vital to a rural community such as Hedgeley.
