It was resolved to co-opt I Smith onto the Parish Council.

### 2021/50 Declaration of Members Interests

Cllr D Carr-Ellison declared an interest in Planning Application NO's 21/03457/FUL & 21/03458/LBC: Titlington Hall Cottage.

## 2021/51 Meeting with Rob Naples, Neighbourhood Planning Services, County Council

Neighbourhood Plans came into being from the 2011 localism act to give communities more of a say in the community and generally contain planning policies. There are generic policies covering the whole of the area in the plan and specific policies which may relate to a specific piece of land or issue. 44 parishes in Northumberland are involved with NPlans, with 17 having theirs signed off and now being used to determine planning applications. There could be a range of different issues, ie. location of housing, business development, protection of local green and open space, defining a settlement boundary. A NP cannot be used to stop development, if the Local Plan for Northumberland sets out a figure for housing in an area, this cannot be lowered. The County Council have a dedicated NP team who provide support, policy writing and technical advice. Government has a funding pot for NPs, administered by Locality, with each parish able to access up to £10K. A Steering Group of the Parish Council would need to be set up, with members of the community and Parish Council representation. Funding can be used for items such as meeting room hire and consultant fees.

## Steps to a Neighbourhood Plan

- Area to be designated by County Council
- Engagement with community NP has to go through a referendum
- Develop vision and objectives statement of intent
- Build evidence Local Northumberland Plan to be adopted early next year there is nothing that has to be included in a NP, unlike a local plan
- Draft policies based on evidence and community engagement
- Screen for environmental impacts County Council carry this out
- Consult and redraft one formal stage of consultation pre-submission consultation there are several statutory consultees
- Submission of plan consultant should be engaged at this time consultation statement required
- County Council check plan and publicise/consult all comments received are sent to independent examiner who produces a report
- Plan goes to referendum County Council cover costs if plan passes, it will be adopted and becomes legally binding immediately
- Locality grant £10K, with any surplus having to be returned; County Council can assist with an information drop-in event; neighbouring parishes could be involved

## 2021/54/01 Works to well/Barbecue area

Grid for top of well problematic, with no contractor willing to construct. Cllr N Birnie to measure well and request quotations. Cllr J Bennet had spare barbecue equipment which could be utilised.

### 2021/54/02 Play area - to approve quotation for wooden pole repair

It was resolved to approve the quotation of £344.00 for pole repairs and planters for Beanley (J Carr- Ellison to pay for the two planters).

#### **2021/**54**/03** Parish drains

County Council had attended site with gulley sucking works carried out, and had looked at flood defences at Glanton. There were weeds coming from drains on A697 opposite the Manse, with Clerk to report to County Council.

## 2021/54/04 Queens Jubilee Canopy tree planting scheme

Tree had been removed from play area due to die back. A small woodland area at the bottom of the play area could be created. County Council were providing free trees, with application accepted for Native Harvest Species. A volunteer had offered to plant the trees, and surplus trees could be planted elsewhere in the parish. Tree on verge near to Bolton Crossroads or on land on the opposite side a possible area, with Cllr D Carr-Ellison to speak to landowner. Land near to the Manse a further option.

## 2021/54/05 Speeding traffic

The speed camera had not visited the parish for many months. Clerk to contact Paul Sykes, with Cllr J Bennet keen to carry out speed monitoring.

As cabinet member for well-being, care for dementia sufferers of importance, there is a Dutch model for dementia villages which Northumberland would benefit from. Road maintenance required to Wooler recycling centre had been reported by the County Cllr for Glendale.
