WHAT DO PARISH COUNCILS DO?

Civil Parish Councils were established as the first tier of local government in 1894, transferring many traditional functions of the church to the new institutions. Pirbright Parish Council was inaugurated in 1895 under the chairmanship of Baron Henri de Worms who became Lord Pirbright later that year. Then, as now, concerns were raised about the condition of local roads, speeding traffic, maintenance of the village green, footpaths and ditches. The minutes of April 1901 refer to the Railway's offer to install (gas) lighting under Pirbright and Brookwood arches, if the council would light and maintain it – the clerk replied that the railway should do this. Further references to this occur over the years, so nothing changes!

So, what do parish councils do?

- Parish councils act as a forum for the discussion of local matters, passing on issues to and from the borough and county councils where appropriate
- Parish councils raise money via a council tax precept, which is spent on parish projects such as the maintenance of the playground and the village green
- Pirbright Parish Council has worked with the Rural Housing Trust to find a suitable site for the building of 13 affordable houses in Cowbridge Meadow
- Pirbright Parish Council is working with Guildford BC and Surrey CC to improve the lighting and safety of Pirbright Arch
- Pirbright Parish Council has worked with Surrey County Council Highways to implement the road safety scheme in the village
- As managing trustees of Lord Pirbright's Hall and Recreation Ground, the Parish Council has an ongoing maintenance and improvement programme at the Hall and playground. Recent projects have included the widening of the entrance to the car park, installation of a fire alarm, refurbishment of the cloakrooms and installation of new equipment in the playground
- The Parish Council promotes the community and village life, supporting and encouraging the clubs, societies and other institutions
- The Parish Council is currently promoting the Community Action Plan
