

# Internal Audit Report

*Internal audit is the periodic independent review of a council's internal controls resulting in an assurance report designed to improve the effectiveness and efficiency of the activities and operating procedures under the council's control. Managing the council's internal controls should be a day-to-day function of the council through its staff and management and not left for internal audit. It would be incorrect to view internal audit as the detailed inspection of all records and transactions of a council in order to detect error or fraud. This report is based on the evidence made available to me and consequently the report is limited to those matters set out below.*

**The council is required to take appropriate action on all matters raised in reports from internal and external audit and to respond to matters brought to its attention by internal and external audit. Failure to take appropriate action may lead to a qualified audit opinion.**

## To the Chairman of the Council:

I met with Nicki Phillips (Clerk/RFO) on 3 April 2023 via Zoom to carry out the year-end audit of the Council. Upon examination of bookkeeping, due process, risk management, budget, payroll, asset control, bank reconciliations and year-end procedures; it is clear that every effort is made to ensure that the Council acts lawfully, transparently and in accordance with proper practices.

The Council has a turnover of under £25,000 and is therefore obliged to comply with the Transparency Code by publishing its financial and governance documents on its website. The Council is not currently eligible to use the General Power of Competence and as such understands that it must ensure it spends within its legal powers (particularly Section 137 under which there was an item of expenditure in 2022/23).

### Issues raised in 2021/22:

- Ensuring that the Council's internal controls and financial procedures with regards to accountability and transparency are as effective as possible for which suggestions included:
  - Obtaining a corporate credit card with defined limits to be cleared monthly by direct debit from the Council's main bank account.
  - Monitoring continually the Council's website to ensure content and links are current in compliance with the latest legislation and/or recommended good practice.


### Issues raised in 2022/23:

- It is evident from governing documents and when speaking with the Clerk/RFO that the Council is fully aware of its responsibilities regarding public finances, especially accountability and transparency. However, these internal controls could be even

more effective by recording the VAT element if any in the minutes as well as the cash book.

Other than the above matter, the Council appears to be performing well, with its business affairs managed properly by a very competent Clerk/RFO and committed Council members.
