<b>3</b>	<b>Approval of minutes of meeting on Wednesday February 24<sup>th</sup> 2021</b> <b>Resolved:</b> Minutes approved
<b>4</b>	<b>Debrief from Parish Council Meeting of 22<sup>nd</sup> March 2021</b> Parish Council in favour of much of the document with some suggested reviews submitted to C Wilkinson by Cllr D Brown and Cllr C Soans with the approval of the PC.
<b>5</b>	<b>Review and approval of core documents for submission to Parish Council</b> <b>Neighbourhood Plan (Ref: Neighbourhood Plan doc)</b> CW took the meeting through the various amendments submitted by the PC and discussion took place as to which the NDPWP felt were acceptable and which needed some further tweaking. <b>Resolved:</b> To add additional wording to 'The Vision', amend Policy B3, B4, B7, B8 B14 and B16 but to reject proposed amendment to Policy B2 with proposed changes to Policy B4 needing clarification from Cllr Soans. <b>Design Statement (Ref: Design Statement doc)</b> No amendments needed <b>Resolved:</b> No action needed
<b>6</b>	<b>Communication to village</b> <b>Resolved:</b> Once final amendments are made and approved the documents will be printed ready for distribution. Help to complete the delivery to all households will require support from all members.
<b>7</b>	<b>Next Steps</b> To seek clarification from Cllr Soans on the map showing historic park boundary. To present amended Plan to the PC for its approval
