#### 16/05/1418 District Councillor's Report

- (1) DCLG Planning Changes Councillor Shacklock informed the Council of proposed changes to the Planning system that might affect the Council. This is still at the consultation stage.
- (2) Councillor Shacklock informed the meeting that ENC are active on littering at present and if litter is found with identifying evidence i.e. credit/debit card slips ENC will take action against the offender.
- (3) Councillor Shacklock had received a letter informing him that a community branch of a Post Office would not even be considered until the present owner resigned

### 16/05/1419 County Councillor's Report - read out by Councillor Hanlon

Northamptonshire County Council continues to have a huge demand on Adult Social Care and Children's Services. Funding from central government has been greatly reduced and this financial year will be challenging. The Council has been aware over the past few years that it needs to move to a new way of working and this year will see the move to community interest

companies (CIC). These services will remain the responsibility of the Council and will continue to operate from Council buildings. The first CIC began operating on 1<sup>st</sup> April and is called First for Wellbeing; it sees County Council staff working with colleagues from health and Northampton University.

I have been pleased to be able to use some of my Empowerment Fund for projects in the village; one of these was a grant for improvements to the almshouses. I am very happy to report that I have received confirmation from Brandon Lewis, the Housing and Planning Minister that the Voluntary Right to Buy will not be available to licensees of almshouses.

Northamptonshire will host the final stage of the 2016 Aviva Women's Tour; the proposed route will start in Northampton town centre and finish in Kettering on Sunday 19<sup>th</sup> June.

Work continues on South Bridge Oundle and I am waiting for confirmation of dates when various stages of the work will be completed.

Heather Smith was elected Leader of Northamptonshire County Council last week and takes over from Jim Harker who has been leader since 2005.

# 16/05/1421 Report from Neighbourhood Development Plan (NDP) with review of Housing Proposal – Councillor Wise reported back on his ideas for future housing in the village and after discussion Council felt further consultation was necessary and suggested the NDP team arrange a separate public meeting to gauge what the community wanted.

Councillor Hanlon reported back that a consultant had been approached to take the NDP forward and would be giving a quote for the cost of his time after which Councillor Hanlon would apply for a grant to cover the costs.

**16/05/1422 Housekeeping Walk Date –** Tuesday June 7<sup>th</sup>, 7.00pm meet at the Industrial Units.

**16/05/1423 Gypsy Lane Byway –** Councillor Hanlon had been to see Thory and discovered the barrier was no longer padlocked. Councillor Soans pointed out it was a criminal offence to block a right of way and that occasionally vehicles used this track. After

debate it was decided to ask the Clerk to contack the Rights of Way Officer at NCC to request a meeting to discuss the options.

- 16/05/1424 Dog Fouling Councillor Shacklock reported back that fouling was still an issue in the churchyard and on the Recreation Field but it would be difficult to obtain Dog exclusion zone status but if offenders could be identified and reported to ENC action could be taken against them. Councillor Shacklock will invite Charlotte Tomkins from ENC to attend a meeting to explain this further to the Council.
- 16/05/1425 Potholes Councillor Shacklock reported that there were several potholes on the approach to Friar Close Farm and requested the Clerk report them to Street Doctor. Councillor Wise who has taken on the responsibility for highways in the parish will contact Street Doctor, the Clerk informed the meeting that reports of potholes can be made directly to Street Doctor by anyone and do not need to be forwarded via the Council.
