# 2021/47 Matters arising from previous meeting held Tuesday 17<sup>th</sup> August 2021

#### 2021/47/01 Road maintenance and winter services within the parish

Clerk had contacted County Council regarding grit bin at Sandy Bank, with query forwarded to Graham Bucknall, Northern Area Highways. A grit bin had appeared at Edlingham church, which would be more useful at the top of road onto B6341 just below the triangle, however this could be the bin ordered for Sandy Bank. Clerk to contact County Council to seek clarification.

## 2021/47/02 Problems due to off road vehicles within the parish

Gates were being left open, and fields churned up. The definitive map orders were considered, however there were no changes to road classifications but the maps had to be updated. It was agreed to invite Sergeant Paul Sykes to the next Parish Council meeting.

#### 2021/48 County Cllr Update

There was a new Chair of the North Area Planning Committee. Regarding the proposed housing development at Thrunton, the County Cllr for Coquetdale had stated the Section 106 funds would be vired to Rothbury, as opposed to providing affordable housing. County Council have funding available for the Queen's Platinum celebrations/free road closures. As Cabinet Member for adult social care, County Cllr is concerned about dementia and would like Northumberland to have a dementia village. Glenn Sanderson wanted Cabinet Members to visit different Parish Council's, with County Cllr having visited Cornhill and Bamburgh Parish Council meetings. There had been disquiet regarding MP Trevelyan however she did not appear willing to meet with rural supporters. County Cllr to contact the MP's office.

## 2021/49/01 Planning Applications received

- 21/00682/FUL: Land North of Old School House proposed holiday chalet, access track and parking area objection submitted, building had been moved closer behind the old school house which did not improve the situation. A traffic speed survey had been carried out.

# 2021/51/02 To receive Definitive Map Modification Order (No 3) 2021 – BOAT Nos 29, 31 & 32, Bridleway No 9 & Footpaths Nos 10, 11 & 24

County Council had made the above orders 17/9/21 with formal notice and a copy of the Order and map received. Discussed earlier in the meeting.

#### 2021/51/03 Seat at Corby bank

Landowner had confirmed they had given permission for seat to be placed at Corby Bank, with Parish Council previously suggesting a memorial tree.

County Cllr suggested a tree and plaque could be purchased for the Queen's Platinum Celebrations.

#### 2021/52 Superfast broadband for rural communities

Government voucher scheme not available at the present time.

#### 2021/53 Northumberland County Council – Statement of Licensing policy consultation

County Council carry out a review every four years, there were no proposed amendments to the document and it was resolved no comments would be made.
