Develop one or more of the main COVID-19 symptoms i.e. a new continuous cough, a high temperature or loss of taste or smell.

Have tested positive to COVID-19 in the past 10 days.

Live in a household with someone who has symptoms of COVID-19 or has tested positive to COVID-19 in the past 10 days.

Have been identified by the TTP service and told to self-isolate because they have been identified as a contact of a positive case.

N.B Further advice from Public Health Wales has identified wider symptoms of coronavirus (fatigue, muscle ache or pain, a sore throat, a headache, a runny nose, nausea, vomiting, or diarrhoea). Individuals are asked to consider taking a test if they are experiencing any of these wider symptoms. Individuals who take a test due to wider symptoms are not legally required to isolate while they await their test result. However, Local Health Boards are encouraging the individual concerned to self-isolate while they await their test result. Children and adults with diarrhoea and/or vomiting must remain away from any play scheme setting until they are symptom free for 48 hours, even if their COVID-19 test is negative
