CADOLE VILLAGE SIGN(S) - AN APPEAL FOR PHOTOGRAPHIC EVIDENCE.

Gwernymynydd Community Council (GCC) have been pursuing residential demands for 'Cadole' village signposting to be displayed alongside arterial roads alerting through traffic to the existence of 'Cadole'. In so doing, Clwyd County Council have responded by stating an approximate cost of EACH of the THREE signs required to be within the region of £600. Furthermore, the charge for installation will be levied against the Community Council(s) concerned. Gwernymynydd C.C. would be responsible for the cost of TWO signs at the proposed 'Tyddyn Dows' - A494(T) and 'Cartrefle' (Gwernaffield Road) locations leaving Llanferres C.C. responsible for the sign at the A494(T) 'Boundary Stone' location. However, the installation cost(s) would be waived if PHOTOGRAPHIC EVIDENCE COULD BE PRODUCED TO PROVE THAT NAMEPLATES ONCE EXISTED IN EARLIAR DAYS! For this reason we appeal to any reader who might be able to furnish the Community/County Authorities with a picture clearly showing the roadside name 'CADOLE' (or even 'CATHOLE'). Suitable photographic proof would then enable Clwyd C.C. to claim a refund from the Welsh Office for providing NEW nameplates and poles so please turn out your drawers folks and lets see what pops up!

Your nearest G.C.C. representative would be delighted to hear of any 'positive exposures' or, alternatively, you could present your 'proof pics' to Mrs Elsie Butler at the Colomendy Arms. Llsie has very kindly agreed to pass on the evidence to G.C.C. on your behalf. Everyone's assistance would be greatly appreciated in this search effort - Thank you all, NOTE THE THIRD Boundary Stone would be located within the bounds of Llanferres C.C. and it is suggested that Cadole residents living in the Llanferres constituency sector lobby their Community Councillor(s) for support in this matter.
