## Town and Parish Council Elections Nomination Pack – Thursday 5 May 2022

Please find enclosed the Nomination Paper Pack for the above election. This includes various pages of forms and notes that are provided as one document and should be returned as one document. On the reverse of this letter is also the *'Timetable of Proceedings'* for the election, including key dates.

All candidates must complete the Nomination Paper marked as document 1a, the Home Address Form as document 1b (only complete Part 2 of this section if you do not wish your home address to be made public) and the Consent to Nomination marked as document 1c. Candidates standing on behalf of a political party must also complete documents 2 and 3.

When completing the Nomination Paper, the electoral number of your proposer and seconder are required. These can be found in the current register of electors or you can call 01480 388017 and we will provide them.

Nomination Papers must be delivered to the Returning Officer on any day between the publication of the Notice of Election, Monday 28 March 2022, but **no later than 4pm on Tuesday 5 April 2022**.

The Electoral Commission publishes extensive guidance to help candidates who want to stand in local elections, including guidance on process, on lawful limits on campaign expenditure and on campaigning rules. Completed nomination papers must be delivered **BY HAND** to the Returning Officer, Huntingdonshire District Council, Pathfinder House, St Mary's Street, Huntingdon, Cambs PE29 3TN during the nomination period. This can be by the candidate or somebody entrusted by the candidate with that task. Please refer to the timetable overleaf as nomination papers cannot be accepted after the deadline.
