# 2023/53/03 Divet Hill Liaison Committee

Blasting the biggest issue, currently towards Clay Walls, then the village, then Newonstead, with speculation blasting impact will be less when wider space opened up, however eventually it will be closer to the village. Most effects of the blast through the air and not thought to cause deterioration to buildings. Larger wagons being used. Breedon had not received any application from the County Council for funds to carry out road repairs/top dressing. It was resolved to ask County Council the current situation.

# 2023/54 To consider issues with path to Church

Concern had arisen due to person slipping. The path is poorly lit, with most of the hazard adjacent to The Manse. Resistance had occurred due to urbanisation of the traditional look of the street. It was difficult to imagine improvements to the surface would lead the congregation to be significantly increased. The church may be considered for closure at some time in the future.

# 2023/55 To consider issues with cattle grids from village to B6342

Cattle grid had been fixed infront of Great Bavington Farm, however this had had not been carried out correctly with bolts exposed having caused a hazard/created a channel. It was resolved to report and request a site meeting be held with County Council.
